DO NOT ENTER membership changes associated

with the 2014-2015 Fraternal year until the 2013-2014 Annual Membership Report has been filed. Failure to comply with these two items will cause the Lodge membership total to be off. No corrections can be made until next year. Any questions, call your CLMS State or District Coordinator.

May 1, 2014, is the last day for filing the Annual Membership Report, Charity Report and for the per capita check to be postmarked. Per Statute 16.010, failure to comply with this date can result in a \$100 fine

## E-cig smokers: Do you know what you're inhaling?

Electronic cigarettes, also known as e-cigs, are battery-operated devices that produce a largely odorless water vapor of highly addictive nicotine when inhaled into the lungs.

Puffing an e-cigarette, also called vaping (vay-ping), can take place in non-smoking environments and are not regulated in most states. They do not carry federal health warning labels.

Electronic cigarettes sound fantastic. Rather than fill your lungs with tar, they deliver a vapor of nicotine to satisfy your craving, without the nasty side effects. They are popularly perceived as the safe alternative to cigarettes, a harmless way to get a nicotine hit, but are ultimately harmful because of their nicotine.

E-cigarettes are poised to be a billiondollar industry, as they promise to lift the stigma of smoking and are increasingly permitted at indoor facilities where smoking is banned.

So, are e-cigarettes safe? Well, they're not great for you, doctors say. What's being debated is the degree to which they are less dangerous than traditional cigarettes.

Unlike tobacco products, e-cigarettes aren't regulated by the Food and Drug Administration. In 2009, the FDA warned consumers about potential health risks after analyzing nicotine cartridges from two leading brands. One sample was found to contain diethylene glycol, a toxic chemical used in antifreeze, which

produces the white smoke to imitate a real cigarette. Several other samples were found to contain carcinogens, including nitrosamines; and those coming from China – who knows what they contain?

E-cigarettes are marketed to smokers to wean them off of tobacco (although studies show they don't help much); yet the same devices are marketed to young people who don't smoke, which could get them hooked.

Cancer and respiratory experts see the same ploy being played out today with e-cigarettes as was done in the 1940s with cigarettes, when Americans started smoking en masse. They often are distributed for free and pitched by celebrities and even doctors as cool, liberating and safe, but in reality they are

Recognizing the important activities we do in our Lodges cannot be overemphasized. Information contained in the Annual Report allows the Government Relations Committee and every Elks Member to bring to the attention of government agencies and legislators the impact we have on youth and veterans in our communities.

Last Lodge year, cash contributions by Members and volunteers totaled nearly \$54.4 million. Combined with non-cash contributions topping an amazing \$367.7 million. That is an astounding grand total of \$422.1 million.

A report of activities can be found in the December/January issue of *The Elks Magazine*. Please publish that report in your Lodge and State Newsletters.

For 2013-14, the Elks National

Foundation has pledged a record \$26 million in grants and appropriations, including \$8.5 million to invest directly into our Lodge communities.

The information from your annual reports, combined with the ENF pledges, gives every Elks Member unequaled knowledge to supply community leaders and legislators with factual results of our Order's works.

We urge every Exalted Ruler, Officer and Member to make Government Relations a priority. Keep a constant vigil on all legislation at all levels of government, to see there is no indifference to unfair legislation that would prevent us from having the rights and privileges we enjoy as a private organization. All of us really are Members of the Government Relations Committee. Your eyes, ears and individual help are invaluable.

# Speeches, prayers are tailor made for many Elks events

Elks Lodges in the market for specially made speeches and prayers tailor made for Elks events can get them with publications written by Past Grand Chaplain, the Rev. Father Kevin Cassidy.

A collection of speeches tailor made for those Elks events is available in "Father Cassidy's Speech-O-Matic," a 91-page booklet of speeches on topics ranging from acknowledgment of awards to welcoming visiting Elks.

For Elks on stand-by to say a prayer, Cassidy is also the author of a twovolume prayer book set, which includes his first (or classic) edition of Father Cassidy's Elks Chaplain Prayers and More Elks Chaplain Prayers (or New and Improved Volume II).

For the Speech-O-Matic, write a check for \$8, made payable to Father Kevin Cassidy. The prayer books are \$16 for the set or \$8 individually. Costs include shipping.

### Assistance available for worthy, needy Members

Needy Elks Members can qualify for up to \$1,000 in an emergency 50-50 matching grant from the Order under Section 5.070 of the Grand Lodge Statutes.

The assistance would be available to "worthy and needy Members of the Order who are suffering from diseases of an incurable character or from total disability, and who are without funds or property or relatives able or willing to care for them," the Statute states.

The Statute also provides that the Lodge of the assisted Member "shall contribute toward the relief of the Member

an amount not less than one-half of the sum that is contributed by the Order."

The assistance program is administered by the Board of Grand Trustees, which is authorized to appropriate up to \$10,000 annually for the program. The board by resolution may give the Grand Exalted Ruler up to \$1,000 so that authorized payments may be made regularly by him.

"The monies so appropriated shall be administered by the Grand Exalted Ruler with the consent of a majority of the Board of Grand Trustees," the Statute states. **EXTRA! EXTRA!** – At its February meeting, the Elks National Foundation Board of Trustees approved the appropriations and distributions for the 2014-15 fiscal year. cannot be a Lodge Officer; and only one person may be chosen. Postmark name to the Grand Secretary between January 1 and March 31, 2014.

Officer of the Year – The Exalted Ruler Shall direct the Lodge's Past Exalted Rulers Association to select the Officer of the Year. Must be a Lodge Officer – only one to be selected. Cannot be issued before January 1, 2014. Postmark full name and title of your honoree to the Grand Secretary between January 1 and March 31, 2014.

#### **Outstanding Member Award**

- Members who have brought in three new or reinstated Members will receive a message of thanks and a GER Award Pin. (Lodge Secretary should forward to the Grand Secretary notice in writing of eligibility for Member recognition. Postmark deadline is June 15, 2014.

GER Outstanding Service Certificate – Exalted Ruler may issue two GER Outstanding Service Certificates to Members performing outstanding service to the Lodge. Order certificates from your Area Member of the GL Fraternal Committee. Requests must be postmarked by March 31, 2014.

The Grand Lodge Fraternal Committee pamphlet, "Lodge Activities Programs, Contests and Grand Exalted Ruler Awards," details all Grand Lodge Programs and Contests, including those listed above. I strongly suggest the retiring Exalted Ruler and Exalted Ruler-Elect review the pamphlet, along with the Lodge Activities Manual, to familiarize themselves with the Programs and Awards available to them. When you look at membership numbers of Lodges that have positive membership growth and very low lapsation, you know that Lodge is working throughout the year and is making a final big push right now.

Get on the phone and make the call because saving those delinquent Members is never too late! Personal contact might completely change their minds, not only on keeping their membership intact but also possibly to make them productive volunteers in future endeavors.

set up to do and we do so very well in certain locals.

We encourage every Lodge and Association to get involved in the program. There is not a city or town in our country that isn't touched by the deployment of our military – our neighbors and friends who in many cases are putting everything on the line for us. If your Lodge or Association is not now involved, it is not too late to start. For specifics on how to get started contact:

Some areas of service your Lodge and/ or Association may be able to provide are:

- Have a "family-oriented" dinner at the Lodge in honor of our troops and host the families and Guard/Reserve representatives. This is a great way to introduce the families and Reserve or Guard representatives to the Elks volunteers they will be working with.
- Supply the families with phone cards.
  - Provide lawn mowing, landscaping

or sprinkler service.

- Perform automobile repairs or transportation when needed.
- Complete minor home repairs, such as plumbing, or painting, etc.
- Provide either full time or "back up" babysitting service.
- Send comfort care packages to our troops (check with local military bases for requirements and regulations).
- Send copies of the service person's daily hometown newspaper.
- Have a photography buff in your volunteer listing? Take some pictures of the soldier's family and possibly some local sights to send to the troop member.
- Participate in "Welcome Home" events at airports, military bases and the like for these returning "Heroes".
- Host a "Welcome Home" party at your Lodge, or for the troops who return home, and thank them and their families for their service.
- Hold fundraisers at the Lodge to provide monetary support to families (of those serving, returning and/or fallen) as identified and appropriate.
- Help each returning "Hero" in their efforts to pick up and continue with their normal life with their family financially and otherwise (doesn't always require

money to provide help).

- Through fundraising activities, provide funds for rehabilitation activities, services and facilities.
- Organize groups of Elks Members to show proper honor and respect to the Fallen Hero, and comfort to the family when they are returned home (be a part of any procession, services, etc.).
- Provide Lodge facilities for funeral- and memorial-related activities for the Fallen Heroes and their families. Do everything you can to ensure the Fallen Hero is given the respect and honor he or she deserves, as well as help the family cope with its devastating loss.

There are many ways Elks Lodges and Associations (our Army of Hope) can help our Heroes and their families, making their lives a bit more comfortable and hopefully less stressful while their family member(s) serves. And on their return, give them the help, respect and honor they deserve in carrying on their lives – whether it be returning to normal activities, rehabilitating or being put to

Our Army of Hope should always be there! And your Lodge and Association should be a part of our Army of Hope efforts!

## Adopt-A-Vet: Now is the time to make a difference

The Elks Army of Hope was established and became an Elks National Veterans Service Commission Program in the 2003-2004 Grand Lodge year. It is now in its 10th year of providing needed service to our military personnel and

The program enables, encourages and provides a path by which Lodges and State Associations can support and assist their local Active Military, Military Reserves and National Guard Units who are deployed in "harm's way", as well as their families who remain at home. Our Army of Hope Program has flourished and grown to be of major significance in many

The need is definitely still there, as we continue to have troops in "harm's way" – and who are still making unimaginable sacrifices on a daily basis on our behalf. And their individual families are right there sacrificing with them, in ways that you and I will hopefully never have to experience. These sacrifices run the gamut from simply needing help and support of a material or financial nature to major issues involving health, rehabilitation and death situations that may require financial, emotional and always moral support – all things that this program was
