I hope this article finds my brother and sister Elks safe and our Lodges all open. This year has no doubt been tough on all of us. As I write this, two storms in the Gulf threaten many of our Lodges. I bought a 2021 calendar the other day and the clerk said she was impressed by my optimism!

With all the challenges of 2020, some things have changed, but the Elks have not. Our schools and communities need us now more than ever. A change to grant guidelines allowed for direct monetary support of local programs, which coupled with local Lodge efforts can make an even bigger impact. So, I am optimistic!

Of course, this is where we always insert "please remember to submit a charitable report form to your Lodge Secretary." But it is more important to know why, community should know about it, and it

Last year the Elks contributed over \$381 million worth of time and money-as well as goods and services-to hundreds of worthwhile programs throughout the nation. Tracking this generosity online is one of the key ways we maintain our 501(c)(8) tax exempt status with the Internal Revenue Service. Fun fact: Last year's contribution brought the total to over \$8.4 billion since 1878.

I would like to encourage each Lodge to track their annual charitable giving history and use that information for news articles, community presentations, and even a banner! You don't have to go back to 1878; CLMS has Lodge giving records that go back 16 years. What would your Lodge total in just the last five years?

That should be another source of pride we all have in our organization. The

and to explore what local Lodges can do could even start a friendly competition with other Lodges in your district!

Back to the pandemic. In 1918 the country was hit by the Spanish Flu, and it is interesting to read the concerns and issues similar to what we have dealt with. During that time, Elks nationwide gave and supported their communities, just as we are today.

As reported in three issues of the New Orleans Times-Picayune: "Rising to the occasion, the Benevolent and Protective Order of Elks established a free dispensary to provide medication and food to the poor and organized 18 physicians to provide their services. By October 27, doctors working at the Elks lodge made close to 12,000 medical visits."

Charitable giving in 1918 increased 30% nationally. Let's keep track of all we are doing and try to make this year a similar increase with all you are doing.

## **ELKS NATIONAL FOUNDATION ENF** staff adds two scholars

National Foundation's staff are testaments to one of our guiding tenets: Our program recipients can be champions of the Order. Grace Roebuck and Jessica Carter, Elks scholars who are now ENF Scholarship Office members, are championing the goals of the Foundation-to build stronger communities.

A 2016 MVS National Finalist sponsored by South Kingstown, RI Lodge No. 1899, Grace Roebuck studied psychology and studio art at Vassar College. She graduated in May.

She's the fourth Elks Scholar Fellow, a fellowship position offered to Elks scholars to gain experience working for a nonprofit while overseeing the service trip program. Roebuck is poised and ready to lead service trips when it's safe to do so-she's attended three Elks Scholar Service Trips, including 150 for 150 during the 2018 Elks National Convention.

"I personally grew a ton from service trips and really made great friends and meaningful relationships, so I am ecstatic to help scholars make those connections and grow like I got the chance," Roebuck said. "Being able to connect with people through something as pure and as important as service is really what creates that glue that cements you for life."

> Carter is a 2015 MVS National Finalist sponsored by Elgin, IL Lodge No. 737. Carter attended Northwestern University and graduated in 2019.

> During her college career, Carter attended the inaugural Elks Scholar Service Trip in Manistique, Michigan, and she served a four-year term on the Scholar Advisory Board.

> Before joining the ENF, Carter was slated to teach in Armenia as a member of the Peace Corps, but the pandemic forced the Peace Corps to suspend its volunteer programs indefinitely-which led her to the ENF.

> "I wouldn't have been able to go to college without the MVS scholarship, and because of that, it was important to me to work with students after graduation," Carter said. "I'm excited to be able to get to do that through the ENF scholarship department."

> For 2020-21, the Elks National Foundation allocated \$2.9 million to fund the Most Valuable Student scholarship program, which includes 500 four-year scholarships ranging from \$4,000 to \$50,000.
