**A Message from ENF Chairperson,

Hello Everyone,

As we move into a new fraternal year – it is time to think about all of the great things that the Elks National Foundation (ENF) does for our communities. ENF is the backbone of the great things that we as Elks do for our community. It provides us with grants to for our Veteran activities, Youth activities and scholarships and other community support programs. Each year the ENF establishes a budget that funds not only programs for the local lodges and their respective communities, but also provides funds for our Major Project of the California-Hawaii association - "Purple Pig".

The Elks National Foundation Board of Trustees has approved appropriations and distributions for the 2021 – 2022 fiscal year of \$39.8 million – and below is a summary of many of the items in the budget:

- Community Investment Program (Grants) = \$14.9 million
- State Grants – (State Charities, Special Project Grants and Bonus Grants) = \$10.3 million
- Scholarships – Most Valuable Student = \$2.9 million; Legacy Awards = \$1.6 million, and Emergency Educational Grants = \$130,340.
- Youth Activities:
 - Hoop Shoot Free Throw Program = \$1.1 million
 - Drug Awareness Program = \$1 million (which includes a DEA Grant of \$225,000)
- Elks National Veterans Service Commission = \$4 million

As you can see above, the monies that each and every member donates strengthens our ability to do wonderful things for our communities.

You can donate in many ways, including designating an amount during your Annual Dues payment, donations through the lodge office at any time throughout the year, or go to Elks.org and donate on-line. An easy way to donate is to join the Fidelity Club with a routine, pre-set amount. Thanks to all of our members who donate so we can continue to support our community.

**A Message from Veterans Chairperson,
MARTHA QUIJANO**

Hello my fellow Elks,
I would like to bring you up to date regarding our relationship with various Veterans Associations in conjunction with our Veterans Charity Program. Here is a brief background on how our program works: The Elks Organization offers a series of monetary grants which is available to all Lodges in various amounts. Depending on the dollar amount for any of these Vets' grants, we try to identify Vets that need support over and above what they are provided by the government. As you are aware, we started out working with the Veterans Hospital in Long Beach some years ago. We would take them toiletries, clothes, magazines and books. We also started working with the blind Vets and the community living Vets. We have had them at our Lodge and

visited the Redondo Pier and Veterans Park, had a Barbeque and games of Bingo. We have had a group of Patriotic Singers who led the Vets in singing these songs. And I'll tell you, it is a lump in the throat time when you watch these young Vets with grizzled old ones singing with pride their commitment to the good old USA.

The Hospital has been in lockdown since the Pandemic hit and we cannot get on campus. They really look forward to our visits and our sing-alongs.

In the meantime, I have uncovered another Vets organization who we have been working with and who have rescued Veterans off the streets and brought them into the campus of the US Vets in Long Beach. They are led through a process of receiving help mentally and physically to the point where they are prepared to eventually move out on their own with the help of the US Vets, who furnishes the bare necessities to a place they can call home. This is where the Redondo Beach Lodge comes in and fills in the gaps which are not covered by US Vets.

We have donated clothing, coffee pots, can openers, haircuts, pictures for walls, TVs, microwaves, bicycles, workout weights, books, full length mirrors, bedding, rugs, and other things.

We have also developed a special program called adopt a Vet, where the case managers will let us know who needs what to complete his transition to a new life. This is set up as a scholarship incentive to get the Vets to transition faster from depending on others to taking care of themselves. This also includes teaching them computer skills, preparing a resume, dressing for success and numerous other things.

Basically, the above is an example of what we have been doing to help these Vets to get back on their feet and have a normal life. In January, we fed 150 Vets at US Vets in Long Beach because their kitchen was under quarantine due to Covid-19.

The above actions include returning Vets who have been deployed and have nowhere to return to and the US Vets take them in as well.

We are very proud of what we have accomplished and hope you are too.

SENIOR PARKING METER PERMIT: If you are 62 or older and drive a car currently registered in California, you can purchase a parking meter permit for \$25.00. The permit allows you to PARK FOR FREE in City Lot 4 adjacent to the North side of the Lodge and the Esplanade parking lot in front of the Lodge – between the Lodge and South Catalina Avenue. You can obtain an application or go directly to Redondo Beach City Hall at 415 Diamond Street and ask for an application.

House Committee Summary for Fraternal Year 2020-2021

Even though the Lodge has been closed for Lodge activities, the House Committee and our members have still been busy in multiple areas that support the Lodge and our community. We started holding regular Lodge, House Committee, and Trustee meetings via Zoom in April 2020 and have continued throughout the fraternal year.

Membership

We started our fraternal year with 740 members and currently have 749 members.

As of March 22, 2021, we have 58 members that are delinquent and our lapsation rate is 8%. Efforts to reduce the rate were facilitated with the use of the Grand Lodge sponsored auto-billing program which sends our delinquent members monthly reminders. We also called each of these members and reduced the delinquency rate from 15% in August to the current rate of 8%.

ENF and CHEMPI

Our ENF per capita of \$22.89 and we are currently ranked #7 in the State for per member donations. Our CHEMPI contributions as of February 28, 2021 are \$7,137.80.

Fundraisers

Our first virtual fundraiser was to support ENF was held in July and raised \$2,100. Thank you to our ENF chairperson, Linda Williams, for organizing this successful event and Jennifer Coleman for managing the Facebook posts and coordinating the Zoom event.

We held our first of eight drive thru BBQ's and Thursday Night Dinners on August 1 and thru March 18, 2021 raised an additional \$5,805 for the Lodge.

For Christmas we had a See's Candy promotion which raised \$1,731.64 for the Lodge.

In February, we started restaurant fundraisers where members patronized Chipotle and Panda Express. Our Lodge will receive a percentage of the proceeds.

The Leading Knight raffle raised \$4,107 for the Lodge. Thank you to Liz Dye and Gloria Steck for their efforts in identifying and executing fundraising opportunities for Lodge.

Thank you to Bruce Harris and Lamont Steele for their culinary expertise with our drive thru BBQs and Dinners.

Grants

We successfully applied and were approved for the Gratitude, Beacon, and Spotlight Grants. The Gratitude Grant of \$2,500 was used to help two organizations in our area. The 1736 Family Crisis Center and Project Joy at St Andrew Presbyterian Church.

The Spotlight Grant for \$2,000 went to New Challenge Ministries which is a food bank in the South Bay area that serves those in need. The Beacon Grant of \$3,500 will be used to purchase backpacks, school supplies and necessities to help students at Rogers and Adams middle schools. It will also be used to support Veterans and Homeless.

Thank you to our Grants Committee Chairperson, Michelle VanLerberghe, for obtaining these grants.

Lodge Rentals

Our Lodge Rentals were virtually nonexistent this year due to COVID-19 however we used the downtime to update the Rental Agreement and our rental rates. We have just recently seen an uptick in interest for our Hollywood Rentals and have been able to rent the South Parking Lot for a new Amazon series. Other inquiries to rent various areas within the Lodge are in process. Our new Hollywood Liaison Chairperson, Lori Marple-Pereslete has presented a plan to formalize the Hollywood rental process and market our Lodge to the various film studios and independent producers.

Lodge Activities

The Lodge's Scholarship Committee awarded six scholarships to high school seniors in our community in August and acknowledged scholarship recipients in a Lodge meeting via Zoom on August 18. For this fraternal year we have submitted our Lodge finalists to District and are awaiting results. Three of our District finalists will be moving on to the State competition.

We held three drive through community events which included the Halloween Trunk or Treat where members and friends decorated their car trunks and gave out treats to over 100 children.

We held a drive thru Christmas gift donation event where over \$5,000 of gifts for boys and girls were given to the 1736 Family Crisis Center.

We had a drive thru Santa event where families in the community were able to have their children greeted by Santa and Mrs. Claus and receive candy and Drug Awareness coloring books and pamphlets.

We were also able to support the US Vets organization in Long Beach with contributions of clothing, appliances, and other items. In early January, we donated 150 dinners to US Vets because their kitchen staff had to quarantine due to COVID-19.

The Scouting program had a successful year despite the Covid restrictions. To date, we have had 13 Boy Scouts reach the rank of Eagle Scout and 7 Girl Scouts attain their Silver awards. We expect a few more before the end of this fraternal year. Our Lodge has also been able to assist our Boy Scouts by allowing them to utilize our Lodge Parking Lot to

work on their Eagle Scout projects under strict County Health Department and BSA Covid guidelines. If it were not for the Elks allowing our property as a venue to construct these projects, many of these Scouts would not have been able to finish the Path to Eagle. Special Thanks to Gloria Steck and Liz Dye for leading these community events and to Sal and Martha Quijano for directing our support of the Veterans.

Lodge Business Operations

The Lodge Trustees initially submitted the Lodge approved the 2020- 2021 Budget in April 2020, but several changes have been made due to the pandemic. We had no club revenue or Lodge rental income and have significantly reduced operating expenses for janitorial services, subscription TV for the club, and other non-essential expenses. It has been a difficult year, but our members have stepped up with over \$11,000 of cash donations to cover Lodge operating expenses responding to a request from our Lodge Trustees.

In August we added a unique member to the Lodge. A beautiful 8' Elk statue now adorns the entrance to our South Parking Lot. Thank you to the members that made this generous donation.

Reopening Plan

Now that the COVID-19 restrictions are beginning to ease, and the vaccines are being administered we are looking forward reopening the Lodge. As always, we will continue to keep members posted on changes/updates to the status via the newsletter, our Facebook page, and Elktivites weekly email announcements.



TRUSTEE YEAR IN REVIEW 2020-2021

- Trustees looked at Google Suites for video conferencing, document sharing, spreadsheets, calendar sharing, Google docs for future business activities. Determined that this program was too expensive for the Lodge to invest in at this time.
- Paperwork for the roof was approved by GL.
- Door upgrades put on hold for now.
- Linen room was reorganized and relocated to Esplanade side room.
- Columns in Dining Room repainted due to rental damage.
- 2020-021 Budget approved.
- Soffits repaired.
- Roof leaks temporarily fixed until further work can be done. Filed complaint on Roofer and received \$7500 compensation.
- Hired a new accounting firm, PBJ Inc. to audit our books and prepare our taxes.
- Purchased new fire extinguishers.
- Repaired the Bell in the South Bar.
- Relocated the tool storage room to the cloak room.
- Re-installed a Changing Table in the Women's RR
- Installed a new key lock on Esplanade Room doors and baseboards were installed for the new wall.
- Installed the Elk statue in the planter box at the South Entrance.
- Revised Rental Contract.
- Updated Confidentiality Agreement.
- Waiting for final permitting for installation of the flagpole at the south entrance by the Elk statue.
- Able to negotiate with Janitorial Service for a reduced fee since Lodge is closed at this time.
- Replaced the rubber mat outside the front door.
- Received an organ donated by a friend of Liz and got rid of old organ that had no value.
- Requested donations for the general fund to cover budget deficits for this fraternal year and have currently received over \$11,000 from concerned members.
- Repaired heating unit in the Lodge Office.
- Contracted for a smaller trash bin since we are closed and are not generating as much trash.
- Considered a solar power installation prepared by K12 Solar Power Company but decided not to pursue it because we didn't use enough electric energy to justify the purchase.
- Purchased a two-tiered table for buffet usage, that was donated by Gloria Steck at no cost to the Lodge.
- Set up a plan for redoing the North Dining Room (NDR) and replacing windows in South Bar and NDR
- Determined a plan for redoing the signs and posts in the parking lot.
