Every 5 years, the Lodge must submit a General Revision of all its Bylaws and House Rules to Grand Lodge. After review, the bylaws committee has compiled the attached recommendations to the lodge including proposed changes, as well as, unchanged items.

Bylaws Committee Proposal: December 19, 2022

Bylaws Revision Vote: January 16, 2023

The following are the substantive proposed changes, additions and deletions.

Article III: Life and Honorary Life Membership, Section 1.

Deletion. ", and who shall attained the age of not less than 65 years." Reflects the 2022 Statute Amendment, which no longer requires age to attain Life Membership.

Article III: Life and Honor Life Membership, Section 3.

Addition. Adoption of limitation of Life Membership totals of Fifteen percent (15%).

Article IV: Meetings. Section 1.

Change. Changed section to reflect Monday meeting days.

Article IV: Meetings. Section 2.

Change: Changed section to reflect Monday meeting days.

Article V: Elective Officers and Duties. Section 6 and Section 7.

Change. Separated Offices of the Trustees and the Board of Directors. Included Secretary and Treasurer to the Board of Directors as reflected in the 2022 Statute Amendment.

Article VI: Appointed Positions and Duties. Section 4.

Change. Removed value of annual membership dues, to reflect compensation of then-current annual membership dues.

Article VIII: Committees. Section 1.

Change. Updated to reflect inclusion of Financial Reporting System described within the Statutes.

Article IX: Club Operations and Management. All Sections.

Change. Defined "House Committee".

Article X: Fees and Dues. Section 1.

Deletion. Varying age of applicant and installments of initiation fee.

Article X: Fees and Dues. Section 2 (b).

Change. Updated to reflect \$2 increase.

Article X: Fees and Dues. Section 2 (c).

Change. Updated to reflect \$2 increase.


