Purpose of Agreement:

This agreement outlines the terms and conditions for camping at Golden Elks Lodge #2740 (hereafter referred to as "Lodge"). By signing this agreement, the Camper agrees to comply with all rules and regulations set forth by the Lodge.

1. Duration of Stay

The camper is authorized to stay at the Lodge’s camping facilities from _____ to _____ (maximum of 10 calendar days)

2. Rules and Regulations

- **Site Usage:** The camper agrees to use the assigned site only for camping purposes and to keep the site clean and orderly. Camper understands and agrees that Lodge is providing a “dry camping site and provides no services.
- **Noise Levels:** Noise must be kept to a minimum to respect other campers, neighbors and Lodge members. Quiet hours are from 9:00 PM to 8:00 AM
- **Fires and Grills:** Outdoor wood, charcoal or similar fires are not allowed. Propane or other fires/grills or similar that can be shut off instantly are acceptable. This rule may be superseded by local fire restrictions at any time. It is the camper’s responsibility to check local restrictions. Please see <https://www.jeffco.us/511/Fire-Restrictions-Bans> for current restrictions.
- **Fireworks:** The use of fireworks is strictly prohibited.
- **Hazardous Materials:** Hazardous materials are strictly prohibited from being brought onto the Lodge property.
- **Pets:** Are allowed if kept on leash while outside of camper. Excessive noise from pets is not allowed. (Barking). You must clean up after you pets and dispose of the waste properly.



- **Alcohol and Drugs:** The Lodge strictly prohibits the consumption of alcohol or the use of any drug (legal or illegal) on its property. Alcohol consumption within the confines of the Campers living quarters (inside of their camper) is acceptable. Prescription medications are acceptable.
- **Guests:** All guests must be registered with the Lodge and adhere to all Lodge rules.
- **Dumping:** All dumping of waste (either liquid or solid) is strictly prohibited.
- **Illegal Activities:** Any and all illegal activities are strictly prohibited and may result in the Camper being asked to leave the property immediately at the sole discretion of the Lodge. The camper agrees to leave the property within 8 hours of verbal notification of the Lodge that it wishes to terminate the agreement.
- **Safety and Security:** The camper must adhere to all safety regulations and report any suspicious activities to Lodge staff.
- **Damage:** Camper agrees to repair any and all damage caused by camper and to restore the area to the existing conditions prior to Campers arrival at Campers sole expense.

3. Liability and Insurance

The camper is responsible for their own safety and the safety of their belongings. The Lodge is not liable for any injuries, damages, or losses that may occur during the camping period. The camper should carry their own insurance if necessary. For the sake of clarity, you are camping and parking solely at your own risk.

4. Termination of Agreement

The Lodge reserves the right to terminate this agreement and ask the camper to leave if they fail to comply with the Lodge's rules and regulations.

5. Miscellaneous

- **Modification of Agreement:** Any changes to this agreement must be made in writing and signed by both parties.
- **Governing Law:** This agreement is governed by the laws of Jefferson County and the State of Colorado.

6. In consideration for being allowed to park my unit in the appropriate area designated by the Lodge, I hereby agree to indemnify and save harmless the Lodge from any and all claims and expenses arising out of my parking or use of the facilities, except for the sole negligence of the Lodge. I further agree that no claim for damage to my property will be made against the Lodge under any circumstances and that any rights of subrogation for damage to my property are waived.
