From the Board of Directors

All Elk's members that have Lots leases located at the Denison Elks Lodge #238 Lakesite, should read their Lot Lease Rules and Regulations. Here are a few of the rules: 1) All lot/ entity property boundaries are an estimate and come as is. It is up to the new lessees to have the property surveyed before leasing if desired and at the lessee's expense. In all property disputes, the final decision and authority rest with the Denison Elks Lodge Board of Directors. 2) Any lot/entity that currently share a septic system, shall share the cost of any repairs and maintenance to the septic system to which they are connected. 3) Mobile homes must be of modern construction and design and stationary homes must be of material approved by the lessor. All waste facilities must be properly connected to a septic system that is in working order. 4) No building or addition shall be erected without prior approval of the lessor. All plans for construction must be approved by the lessor in advance. CONSTRUCTION NOT APPROVED MUST BE DISMANTLED AT THE LESSEE'S EXPENSE. Trees and bushes must be approved before removal also.

The Board of Directors meets every month on the Monday before the second Wednesday of the month at the Denison Elks Lodge in Denison. You can attend the meeting and bring a letter of description and diagram detailing what you wish to erect or remove. Or you can send copy to the Denison Elks Lodge #238 at 301 W Gandy, Denison, TX 75020 for approval. Fraternally,
