VETERAN'S CORNER by Tom Carroll

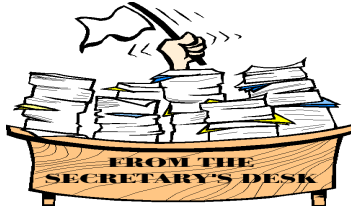


A few months ago I wrote an article on the issues facing the Korean War Veterans Association and the Vietnam Veterans of America due to the "aging" of their membership. While I gave some detailed information on the plans of the VVA, I mentioned that I did not have any information on the plans of the KWVA.

Since then, I have spoken to some local KWVA members, as well as Sheila Fritts, the membership spokesperson for the national KWVA. The single initiative undertaken by the KWVA has been to open their membership to any veteran who served in the Korean Augmentation to the US Army (KATUSA) in Korea at any time between September 3, 1945 to the present. The former by-law limited membership to those who served, in or out of Korea, between June 25, 1950 to January 31, 1955. The obvious effect of this change is to open up membership eligibility to a younger pool of veterans. There is also an Associate membership available to anyone of good character who has been discharged from the armed forces of the United States under anything but honorable conditions. There are no current plans for dissolution or transfer of assets.

Beginning in June, new "Community Care" guidelines go into effect for those veterans enrolled in the VA Health Care system. Community care allows veterans, under certain conditions, to seek care outside of the VA medical system. Previous guidelines have been if a veteran lives more than 40 minutes from a VA facility, or is facing a wait time of more than 30 days for an appointment. The new guidelines reduce the distance the drive time to 30 minutes and the wait time to 20 days. For specialty care, it is a 60 minute drive limit or more than 28 day wait time.

In the June, 2019 Elks National Magazine (the one with the St. Louis Arch on the cover), there is a very interesting and informative article about "The Silent Service". The article covers the entire history of the United States submarine fleet. If there are any members who served aboard a submarine, I would love to include your story in a future article.
