

HOUSE RULES:

- 1. Hours of operation: Published in the bulletin
- 2. The lounge is nonsmoking.
- 3. The Lounge rooms are closed to everyone during regular Lodge Sessions, except for the Elks Auxiliary, for their meetings only, during the funeral Services for a member, or during Special Ritual Services such As Flag Day or Memorial Day
- 4. The Lounge Rooms are available to:
 - 1. All local and visiting Elks in good standing. (Inactive Elks, i.e. those holding Absolute Demits, those having been dropped for non-payment of dues, or those not currently paid up are NEVER allowed in the Lounge under any circumstances Except that delinquent members may be admitted for the purpose of paying their dues.)
 - 2. Minor children of members when accompanied by their parents. Parents are responsible for the behavior of their children and will exercise discretion in taking their children from the premises at times when it is obviously inappropriate for children to be in attendance. Minor children are never permitted to approach or sit at the bar for service and are excluded from certain other designated areas.
 - 3. Guests of Elks when accompanied by a member of this Lodge. Member are responsible for their guests signing the guest register (NO EXCEPTIONS!), and for their guests' behavior. Guests must abide by all House Rules
 - 4. Elks' spouses, visiting Elks' spouses, and Elks' dependents or widows/widowers with identification cards issued by this lodge.
- 5. All persons issued key cards by this Lodge will use them to gain entrance to the Lounge in lieu of knocking, and thus taking lounge employees from their regular duties to answer the door. ONLY Officers, members of the House Committee, or the Attendant in Charge are allowed to respond to persons knocking to gain entrance.
- 6. Members, spouses, and dependents with identification cards may be requested to exhibit their cards to a Lodge Officer, or a member of the House Committee, or the Attendant in Charge. Visiting members must show their membership cards, sign the guest register, and observe all House Rules. At the discretion of the House Committee, visiting Elks may be given a complimentary drink.
- 7. Guests who are eligible for membership in the Order, but who are not spouses of members and who reside within the jurisdiction of this Lodge, can be admitted as guests occasionally, regardless of who brings them in.
- 8. Employees are under the direction of the House Committee. Members and Guests will neither call upon employees for services which would take them from their regular duties, nor reprimand them for any reason. Any complaints about employees must be directed to the House Committee.
- 9. Members of the House Committee, or in their absence, the Attendant in Charge, have the authority and /or the legal obligation to refuse service to anyone who, in their opinion, is inebriated or is creating a nuisance that interferes with the rights of other members and guests to enjoy the facilitates of the Lounge, and they have the authority to insist that the offender leave the premises. Nuisance is construed to include, but not limited to, loud or profane language, or lewd and lascivious behavior.
- 10. Lounge business is "strictly cash". Members will settle their accounts prior to leaving the lounge on each occasion of their visits to the Lounge. Checks written for change or checks written in excess of the amount owed must be limited by the lounge's available cash, at the discretion of the Attendant in Charge, but in no case, will exceed \$50.00 in excess of purchases.
 - a. As exception to the "strictly cash" policy in rule 10 a member may establish monthly credit accounts with the lounge upon the member's advancing the sum of \$500.00 as a security deposit. Said sum must remain on deposit during the period the member wishes to maintain the credit account. In addition, the member will pay a fee of \$50.00 per month, in addition to purchases, for account maintenance.
- 11. Any member indebted to the Lounge or Lodge by a non-negotiable check must make restitution within 48 hours after notice or lose said member's Lounge privileges until the check is redeemed. After three non-negotiable check (proved to be the fault of the member and not the banking institution), the member loses all privileges to cash checks of any kind, the members or others. "Hold" checks are not legal tender, and will not be allowed.
- 12. Members or guests, under no circumstances, will be permitted to bring into the Lounge anything that is sold in the Lounge. This pertains to alcoholic beverages at all times and food when the kitchen is open and serving. Alcoholic beverages sold in the Lounge cannot be taken from the Lounge.
- 13. No one is allowed behind the bar, or in the kitchen, except employees, House Committee members, or volunteers authorized by the House Committee.
- 14. All properties of the Lounge and Lodge will remain on the premises UNLESS permission for removal is first granted by the Board of Directors of the Lodge. Members will be charged for property lost or destroyed by them or their guests.
- 15. Section 16.041, Statutes of the Order, authorizes action to be taken to disenfranchise a member from the Lounge for violation of House Rules. It is the duty of the House Committee to initiate such action upon observance of any willful violation of those rules.
 - a. It shall be considered "conduct unbecoming an Elk" for a member to park in a Lodge handicapped parking space without prominent display on the member's vehicle, of a bona fide handicapped parking permit. It shall be incumbent upon a member hosting guests, who have vehicles parked at the Lodge, to ensure that said guests also respect the purpose of the parking spaces. It shall likewise be considered "conduct unbecoming an Elk" for any member to utilize a handicapped parking permit for parking at this Lodge under false pretenses. "Conduct unbecoming an Elk" is further defined in the Statutes of the Order.
- 16. The Lounge is authorized to sell and serve alcoholic beverages under permit from the Texas Alcoholic Beverage Commission, and is therefore mandated to comply with the statutes, rules, and regulations of the Commission. Nothing herein published, or presumed due to omission should be construed to take precedence over TABC Regulations, and should conflicts arise, the TABC regulations shall prevail.
- 17. Kingsville Lodge 1926 is a subordinate Lodge of the Benevolent and Protective Order of Elks of the United States of America. Nothing herein published or presumed due to omission should be construed as taking precedence over the Statutes of the Order and should conflicts arise, Statutes of the Order prevail.

There is no better way to recognize these people who have gone beyond the call of duty in their service to Elkdom than to award them with "Elk of the Year," "Officer of the Year," and "Citizen of the Year." The awards form can be accessed in CLMS2Web. They need to be submitted prior to March 31 so that the certificates can be printed and sent back to the Lodges for Officer installations. As an Exalted Ruler, you have an opportunity to recognize those Members who are

doing everything without even being asked.

Speaking of legacy, the Legacy Award scholarship is available until February 3, 2025. It provides \$4,000 scholarships to the children and grandchildren of Elks Members. Use the membership of Elkdom to pay it forward to help your children and grandchildren.

The end of year will be here before you know it. With the FRS system, your Lodge just needs to ensure all entries are current. The nice thing about the FRS system is your Lodge no longer needs to have the annual audit completed. However, you still must submit

your 990 and 990T for each corporation in your Lodge. Have them completed by a qualified individual (e.g., CPA) and filed with the IRS and uploaded on Elks.org. Elkdom's Heart for America means looking for ways to recognize the value of our Members, membership, and the value of looking forward to the future. Keep up the good work you are doing in your Lodge and community. I want you to know how much I appreciate all that you are doing for Elkdom.
