**CHARITY, YOUTH, VETERANS, COMMUNITY—IT'S WHO WE ARE!**

This is my last article as your Exalted Ruler. I thank each and everyone of you for your support this past year. This year has offered its challenges that your Board of Directors and House Committee has worked creatively through. I thoroughly appreciate each of the officers and committee chairs that have served during my term as your Exalted Ruler. If you see any of them, tell them thank you!

Although many of our activities and functions had to be cancelled, we still accomplished a great deal and have kept afloat! I look forward to the continuing growth of our Lodge.

While we were closed or limited during this past Elk year, we accomplished so much!

We applied for four Elks National Foundation Community Investment Program grants—

Gratitude, Freedom, Beacon, and Spotlight, and were approved for all four of the grants. We received a total of \$10,500. As in past years, through these grants we were able to accomplish much of our charity work. Although this year we were unable to be directly involved in many of the grants, we were able to donate funds to organizations helping our community. We donated funds to the Redistribution Center which provides food, furniture, and other assistance to mainly veterans. However, this year they expanded their mission to help people in our community in need due to the pandemic. We provided gifts cards to surviving kids of military families in our community for school supplies, provided a donation to the Colorado National Guard to assist surviving families during the holidays and to assist members of the Colorado National Guard in need. We provided coats, gloves, drug awareness materials, and information from the Golden Library to students in need at various elementary schools. We donated the remainder of

the coats and \$3000 to Serving Kids, an organization that provides clothing to students and families in Jefferson County. Any Jefferson County School District employee, janitor, teacher, lunchroom worker, can refer a student to Serving Kids. In addition, we donated funds to Golden High School's Sources of Strength and Need for Clean programs. Sources of Strength is a student peer program training students to recognize others who may be considering suicide. Need for Clean is a program helping homeless students at the High School by providing travel size personal items, clean socks, gift cards to fast food restaurants, etc.

The Grant Committee will be discussing areas we would like to focus on when the grant applications open in April. If you have an idea, please contact me.

**to the Elks National Foundation (ENF). In addition to grants to the Lodges, ENF provides grant money to the Colorado Elks Association (CEA). The Association is able to utilize these funds for its charitable programs-Laradon, Clem & Evelyn Auden, and the Youth Camp in addition to veteran and other programs. ENF provides scholarships through the Most Valuable Student Scholarship, the Legacy scholarship for Elk children & grandchildren (deadline is February 5, 2021), and an Emergency Education Grant fund which is a one-year education grant to children of deceased or totally disabled Elks. The CEA, through funds provided by ENF, is able to offer to each Lodge \$1000 to utilize for scholarships.**

**The mission of ENF is to help Elks build stronger communities. ENF fulfills this pledge by investing in communities where Elks live and work. They help youth develop lifelong skills, send students to college, meet the needs of today's veterans, support the charitable work of the state Elk's associations, and fund projects that improve the quality of life in local Elks communities. This year, ENF allocated 14.6 million to fund the Community Investments Program—the grants we applied for and received funding.**

**I'd like each member to consider making a donation to the Elks National Foundation. In fact, I'd encourage you to join the Fidelity Club—the monthly giving program. By your generosity to the Foundation, the Lodge, its members, and our community truly benefit. By joining the Fidelity Club, you can donate on a monthly basis (minimum of \$5), its convenient, and you don't have to remember to make a donation, it's automatic! Ready to join or make a donation? Donate or enroll online at [enf.elks.org/recurring](http://enf.elks.org/recurring). Please see the article later in the newsletter about a possible tax deduction for a charitable contribution. ENF is a 501(c)(3).**

**This year we tried several new ideas. For example, we tried to have specific times the Social Quarters were open, we held several community events, had a fundraiser through Pampered Chef, did online games, trivia, and meetings, and we started take out meals. By the way we brought in \$252.83 from the fundraiser! Although we have had a few tight months, so far we have been able to bring in enough income through our take-outs and donations to cover our monthly expenses. Thank you to those that have supported our Lodge during this time. In addition, we have welcomed and initiated seven new members and we have two more candidates awaiting initiation. This is a fantastic accomplishment this year.**

**Another accomplishment is the 'clean up' around the Lodge. So many of the accomplishments were completed through the generosity of many of our members who paid for supplies and provided the time and muscle!**

**Cleaned out the old building on the North end of the parking lot—still have a little bit more to go but we can now discuss the future of this building**

**Painted the Social & Lodge room wood floors**

**New carpet for our bocce court**

**Refinished the bar and cleaned the bar area**

**Installed an exit door on the east side of the building. A few pavers have been donated and in the spring we will begin work on a patio area. We are hoping to obtain additional pavers.**

What's Happening with Elks National Foundation

In a year like the one we have just left behind (See Ya 2020) it is hard to envision all of the good that has been accomplished by our Lodges. Food Baskets, Toys for Kids, Dinners, etc. Many of us have switched our giving trends and that money is being used to keep our lodges open. For that alone I am proud and grateful to be an Elk. Thanks to all of you for your generosity of both money and volunteer time to make our

lodges better than before.

It has taken a while, but we have made the GER Per Capita of \$4.80 per member in the State of Colorado. In fact, as of December 28, 2020 we stand at \$5.41. That's more than halfway to the CEA goal of \$10.00 per member. We did it last year – In spite of it all! – Let's do it again. Think of all the good that came of using the ENF Grants to support our communities when our Lodges were and are suffering the most.

The work that so many of you have done has also been noticed by the community. Now, they want to help us. Many Lodges are still seeing new candidates contact them and want to become Elks even with the doors to the lodges closed and the windows shuttered! Do not miss the oppor-
