## Elks Promote Elkdom with Enthusiasm in 2022-23

Thousands of Elks and guests from all 50 states attended the Opening Ceremony of the 158th Grand Lodge Session, where they learned of the past year's successes by the Elks National Drug Awareness Program, the Elks National Foundation, and the Elks National Veterans Service Commission. The evening's highlight was a presentation by Grand Exalted Ruler Bruce A. Hidley, who congratulated the assembled Elks for "Promoting Elkdom with Enthusiasm" during the past year.

To open the ceremonies, the assembled Elks were welcomed to Minneapolis by PGER Robert L. Duitsman, who encouraged the attendees to take advantage of Minneapolis's many cultural attractions. Duitsman introduced the Past Grand Exalted Rulers and Past First Ladies, followed by GER Bruce A. Hidley and First Lady Helen Hidley. Duitsman then introduced Grand Lodge Fraternal Committee Chairman William J. Lindsey, who oversaw the Parade of Flags, which included the flags of the emergency responders; all 50 states, the District of Columbia, and overseas possessions; the five branches of the US Armed Forces; the POW-MIA flag; and the flag of the Benevolent and Protective Order of Elks. To close the parade, the members of the Grand Lodge Fraternal Committee escorted the world's greatest symbol of freedom, the flag of the United States of America, to the front of the stage and paused as the assembled Elks recited the Pledge of Allegiance.

After the conclusion of the Parade of Flags, PGER Duitsman then welcomed Minnesota State Representative Dave Baker, who spoke about his efforts to bring opioid abuse-prevention

legislation to Minnesota in honor of his late son Dan, who passed away in 2011 from an accidental overdose. Baker congratulated the Elks on the successful work of the National Drug Awareness Program in promoting drug awareness issues on the national stage.

Next to the stage was PGER Millard Pickering, who spoke about the National Drug Awareness Program and the newly created Elks National Drug Awareness Commission, which has helped the Order escalate its efforts on the front lines of the nation's information war against substance abuse. Pickering then introduced a farewell video recognizing the accomplishments of Kent Gade, who is stepping down after serving eighteen years as director of the Drug Awareness Program.

Following Pickering's remarks, PGER Duitsman announced a \$10,000 donation from the Elks National Foundation to the charity My Very Own Bed, a charity located in Minneapolis that provides new beds to children transitioning to permanent housing.

PGER James M. McQuillan, chairman of the Elks National Foundation Board of Trustees, next introduced the reports of the Elks National Foundation and the Elks National Veterans Service Commission. McQuillan began by noting that the foundation has tripled its spending on programs in only 19 years—increasing from \$13 million in 2004 to an impressive \$40 million in 2023–2024.

Next to the podium was ENF Youth Programs Manager Makenna Cannon, who gave a report on the fifty-first annual National Hoop Shoot Finals competition. The event was held at Wintrust Arena in Chicago in April and delivered a tight, suspenseful, sportsmanlike contest as always. Cannon introduced the two winners of the Getty Powell Award for best overall performances at the Finals. The female winner was Morgan Miehle, who was sponsored by Wheeling, WV Lodge No. 28 and competed in the girls' ages twelve and thirteen division.



The champion of the boys' competition was Tommy Goodelle, who competed in the boys' ages twelve and thirteen division, sponsored by Utica, NY Lodge No. 33. Cannon concluded her report with a video of two-time championship winner Bree Besonen missing her opportunity to secure a third first-place finish in 2023. Cannon noted that Bree's performance embodied the qualities of grit and dedication that Hoop Shoot instills in all participants.

Next up to the podium was ENF Associate Director Deborah Kahler Doles, who spoke about the Community Investments Program, which awarded an average of 2.8 grants totaling more than \$8,100 to each of 1,541 Lodges last year, and through which more than 80% of Local Lodges received at least one grant to assist their communities. Doles then introduced a video highlighting the ways in which Greater Pine Island, FL Lodge No. 2781 used a CIP grant to provide support following the devastating impact on the community following Hurricane Ian.

Doles also spoke about the January 2023 Winter Elks Scholar Service Trip, in which 21 scholars traveled to Florida to help Elks at the Greater Pine Island Lodge rebuild their Lodge and their community in the wake of Hurricane Ian. Doles presented a video demonstrating the dedication and hard work of the scholars during their time in Florida.

Doles concluded her report with an update on the Most Valuable Student Scholarship program, noting that in April of 2023, the ENF Leadership Weekend was held in person for the first time in four years. She introduced the top MVS Scholarship winners for 2023, each of whom will receive \$50,000 over four years to complete their college educations, and played video introductions for each of them. The top male winner was Agam Igwe, sponsored by Towson, MD Lodge No. 469, and the top female winner was Diya Jha, sponsored by Frederick, MD Lodge No. 684.

PGER Duitsman returned to the stage and as Elks National Veterans Service Commission Chairman, he gave the commission's annual report. He noted that the Emergency Assistance Program had provided financial assistance to 563 veterans

in 2022-2023 to help them exit homelessness or avoid losing their place of residence. In addition, the Welcome Home Kit program had provided basic household necessities to thousands of veterans moving into new homes. To illustrate the impact of the Welcome Home Kit program, PGER Duitsman introduced a video that showed Elks volunteers in action, distributing kits to veterans in New Jersey. Duitsman then resumed his remarks, noting that during the COVID-19 pandemic, Elks continued to provide needed support to veterans across the country, with Elks volunteers visiting a total of more than 360 VA facilities an average of twice a month to provide entertainment, support, and essential supplies for veteran residents. PGER Duitsman concluded his report by introducing a video highlighting the many ways Elks supported disabled veterans in Colorado during the annual, weeklong Disabled Veterans Winter Sports Clinic – providing essential services that help veterans break barriers.

Finally, PGER McQuillan returned to the stage to cap the ENF presentation by urging Elks across the country to join the ENF Fidelity Club, which involves making monthly donations to the Foundation.

The Opening Ceremony's keynote presentation was given by Grand Exalted Ruler Bruce A. Hidley, who spoke about his successful year leading the Order. He recalled his year of travel and the fantastic work he had seen being done by Elks across the country, noting that the Elks fulfilled his goal of growing the Order, with 41 state associations reporting an increase in membership. In addition, Elks exceeded the GER's per-Member giving goal by an impressive 285.5 percent. Hidley also noted that the selfless work of Elks and the use of ENF resources like grant money has helped strengthen communities in a wide variety of ways-from showing appreciation for veterans to informing young people of the dangers of drug use.

To close his speech and round out the session, he returned to his year's theme of "Promoting Elkdom with Enthusiasm" and told the assembled Elks, "Each and every one of you should be proud of the work that you do for Elkdom every day and for your accomplishments. You have truly demonstrated that you are Promoting Elkdom with Enthusiasm." \*

## Elks donate more than 16,000 hides in 2022-23

The Elks Veterans Leather Program provides services and support that are hard to find elsewhere.

In 2022-23, Elks and volunteers in 11 states donated 16,229 hides to the Veterans Leather Program. Volunteers helped to collect these hides and transport them to our partners, who turned them into leather.

That leather is turned into wheelchair gloves, and Elks across the country distributed 1,378 pairs of these gloves to veterans last year. Every year, Veterans Leather Program volunteers attend national adaptive sports events to meet with veterans and personally distribute these gloves. Each of these pairs of gloves is emblazoned with the Elks logo.

Finished leather is also turned into craft kits, with a little help from our longtime partner Help Heal Veterans (HHV). This past year, Elks donated 64,587 square feet of leather to HHV to make craft kits for veterans. In return, HHV helped Elks volunteers in State Veterans Homes and elsewhere hand out 8,800 craft kits directly to veterans. We know these kits are appreciated because we receive postcards in our office every week thanking the Elks for supporting this program.

Finished leather is also donated directly to VA Medical Centers, which recreation therapists use to plan creative



projects focused on helping veterans recover. In 2022-23, Elks distributed 5,982 square feet of leather directly to facilities for use in therapeutic crafting.

Every year, there's a battle to see which states can contribute the most hides. This year, Missouri came out on top, contributing 6,637 hides. Iowa came in second place with 4,514 hides, and Arkansas came in third place with 2,870 hides. Congratulations to these states!

Thank you to all the Veterans Leather Program volunteers who make this program a success, especially Program Chair Dennis McAleese, and Vice-Chair Chuck Mudge.

## RUSH LAMOTTE HOLLAND AWARD

This award, given to the highest scoring Leading Knight in the Ritual Contest, will be presented Monday on behalf of Colorado Springs, CO Lodge No. 309 PER Association, Colorado State Sponsor PGER John Amen, and the Colorado Elks Association.

In 1893, inspired by a visit to America's Mountain, Pikes Peak, Kathryn Lee Bates penned the famous poem which eventually became the song America the Beautiful. In turn, the Leading Knight charge was also authored at the foot of America's Mountain.

Rush LaMotte Holland was the Exalted Ruler of Colorado Springs, CO Lodge No. 309 in 1902-1903. Holland was a highly respected attorney, and during the Grand Lodge Convention in Baltimore, MD in 1903, Holland was appointed to the Committee on Laws by GER Joseph T. Fanning.

In 1905, Holland was appointed Chairman of the Committee on Work and Ritual by Grand Exalted Ruler Robert Brown. GER Brown instructed the committee to prepare and submit an entirely new Ritual, for approval at Grand Lodge in Denver, CO, in 1906.

Brother Holland wrote the lecture of The Esteemed Leading Knight. This lecture was "written like no other and has stood the test of time and has resisted changes."

On July 14, 1908, Rush L. Holland was nominated and elected Grand Exalted Ruler at the National Convention, held in Dallas, TX.

In 1921, he was appointed Assistant Attorney General of the United States of America. PGER Holland was assigned the task of overseeing the FBI and other departmental divisions. He was also a confident of President

Calvin Coolidge.

It is no doubt that PGER Rush L. Holland exemplified the virtues of Elkdom. Colorado Springs Lodge No. 309 is truly proud of his accomplishments to both our country and our Order.

#### WILLIAM A. KING AWARD

It is our honor to present this award on Monday in memory of William A. King. This award is given each year by the Union City, GA Lodge 1617 to the Officer in the Eastern Division and the Western Division who achieves the highest overall scores of all Officers competing in the ritual contest.

Bill King was an Elk for over 50 years and a Life Member of Union City, GA Lodge 1617. He was active as an Officer, ritual coach, and judge. He was an All American Lecturing Knight and served as a Grand Lodge ritual judge.

In 1991, 1992, and 1994, Bill coached his home Lodge, Union City, GA No. 1617, to three National Ritual Contest Championships. His teams have been Eastern Division Champions five times and have produced 26 All-American Officers.

Bill King's dedication to the Ritual and his contributions to the members of his teams as a coach, mentor, and friend makes this award special.

Bill has passed beyond "The Eleventh Hour" for his Promised Reward, but his love for the Ritual continues in us as it is inscribed on this award given today:

"There is no activity throughout Elkdom that more consistently and continually furthers the fundamental principles of our order than a dignified, impressive rendition of the ritual."





## Student leader, junior firefighter win top MVS awards

In April, 20 high school seniors from coast to coast flew to Chicago for the first in-person Most Valuable Student Leadership Weekend since 2019. They got a chance to bond, learn about their new #ElksFamily, and interview for the top awards of \$30,000, \$40,000, and \$50,000.

Sponsored by Frederick, MD Lodge No. 684, \$50,000 winner Diya Jha was one of 12 students across the United States to be selected for the Bezos Scholars program. Diya developed Let's TALC (Teach, Access, Learn, Choice) to teach students in her school district about the dangers of opioid use.

"Some students shared how they initiated substance use as a coping mechanism for dealing with depression, anxiety and other mental health challenges," Diya said. "I worked on engaging students from diverse racial and

ethnic backgrounds and social groups, such as the student athletes, to reach the full breadth of our high school population."

Diya's program encouraged participation in skill development courses as an alternative to drug use. She instituted public speaking classes, introduced students to oratorical competitions, and encouraged them to volunteer at the local soup kitchen.

Diya plans to attend Yale University and major in computer science.

The other top winner, sponsored by Towson, MD Lodge No. 469,

has been busy lifting 150-pound dummies and running rescue drills. Agam Igwe has been in his community's junior firefighters program since he was 9 years old.

"After six rigorous years of training, two leading battalion cadences, I graduated at the highest rank," Agam said. "I didn't expect the strenuous training, but I persevered, and the leadership skills I acquired molded ambitions of creating more inclusive communities."

This summer, Agam is interning at Johns Hopkins University Applied Physics Laboratory & Children's Hospital, where he will turn data into model representations. Agam plans to attend Stanford University and study engineering. His career dreams include working with surgical robotics, so entire surgeries can be performed remotely.

Membership in the organization is open to any US citizen older than 12 and younger than 21, who is of good character and believes in the existence of God.


The Antlers of the Benevolent and Protective Order of Elks of the United States of America has these objectives:

#### **Summary of Proposed Resolutions being voted on Tuesday**

2023-01—To clarify this Constitutional provision by eliminating a redundancy. \*Final approval of this proposed amendment requires a two-thirds (2/3) majority vote at this assembly and compliance with Article IX of the Constitution.\*

**2023-02**—To prohibit the use of resources of the Order and of Local Lodges for private, public, or social media fundraising activities in connection with a Local Forum or Grand Forum action.

**2023-03**—To prohibit the use of resources of the Order and of Local Lodges for private, public, or social media fundraising activities in connection with a Local Forum or Grand Forum action, and to authorize the Grand Forum to issue a contempt order.

**2023-04**—To formalize the appointment and authority of Special Representative District Leaders or Area Special Representatives.

**2023-05**—To clarify that the determination of whether there exists good cause not to attend a District Deputy Clinic rests with the District Deputy Grand Exalted Ruler.

**2023-06**—To clarify that the determination of whether there exists good cause not to attend a District Deputy Clinic rests with the District Deputy Grand Exalted Ruler.

**2023-07**—To require the Lodge Treasurer to attend all District Deputy Clinics.

**2023-08**—To clarify the types of projects that are subject to the provisions of this section of the Laws of the Order.

**2023-09**—To allow greater discretion for the use of defunct Lodge funds and to allow the Grand Exalted Ruler the authority to appoint a sufficient number of Trustees to administer the funds of a defunct Lodge.

**2023-10**—To allow Local Lodges to adopt a by-law setting a minimum age requirement for Life Membership applicants.

**2023-11**—To define spouse as used in the Grand Lodge Statutes and in publications.

**2023-12**—To require the Grand Lodge to provide a credit to Local Lodges for dropped Members.

**2023-13**—To authorize and prescribe the procedure by which a Member may resign from membership during the Lodge year.

**2023-14**—To allow Members to transfer from a Lodge appealing a Charter revocation.

**2023-15**—To permit and prescribe the procedure by which a Member, who has been dropped for non-payment, may apply for reinstatement in another Lodge when that individual's Lodge has had its Charter revoked and has appealed.

**2023-16**—To allow a Local Lodge Past Exalted Rulers Association to form a separate non-profit corporation for the purpose of raising, receiving, and distributing funds for such charities, educational, and scientific purposes that are supported by its Lodge, State Association, and/or Grand Lodge.

**2023-17**—To make it clear that the Grand Exalted Ruler shall have the authority to remove any officer of a corporation formed pursuant to the new Section 16.035 who neglects the duties of office, or is guilty of contumacy or conduct injurious to the Order. \*This Resolution is dependent upon the passage of Resolution 2023-16.\*

**2023-18**—To allow a Local Lodge Past Exalted Rulers Association to form a separate non-profit corporation for the purpose of fundraising. \*This Resolution is dependent upon the passage of Resolution 2023-16 and 2023-17.\*
