# Recognize future leaders today

Introduced in 2018, the purpose of the JROTC Awards Program is to allow Local Lodges to recognize our future leaders by focusing the public's attention on outstanding cadets from their communities.

Does your Lodge participate in this new program? If not, get involved by following the suggested procedure for setting up a JROTC Awards Program for your Lodge:

1. Locate your JROTC schools by state at the national level through the following websites:

2. Contact the schools in your area that have a JROTC program and ask to speak to the senior instructor to see if they would be interested in participating in the new Elks program. If so, request that the instructor select a cadet whom they feel has proven him or herself to be a true leader in academic achievement as well as community service projects, and one who maintains the highest standards of performance in all fields of endeavor. Be sure to coordinate your efforts with other Lodges in your district that may be close to the same school(s) your Lodge wants to contact. You may want to consider making it a district program with all Lodges in your district participating.

### How to win an Elks website contest

The Fraternal Committee wants your Local Lodge website as well as your State Association website to exemplify the true spirit of Elkdom. Your website should always be up-to-date, be a great source of information for your Members, and cover all Grand Lodge programs.

All Fraternal Committee members are available to assist you should you need help, advice, or information. You may not necessarily be ready to enter in a website contest, but we all should want to continue to improve our websites, so they are the top go-to resource for Members.

The best websites should have these attributes, and the State and Local Lodge contest will be graded on the same criteria with points awarded in each area.

**Content:** This should contain up-to-date news and information along with details about all programs. Some news is timeless, but some information needs to be fresh.

**Layout:** There should be a menu or table of contents. Various committees or departments should be easily accessible.

**Design:** Special presentation methods such as borders, shading, and color are a plus.

**Graphics:** Pop up windows and scrolling messages highlighting important

announcements help. Photographs and graphics keep users' interest.

Effectiveness in telling the Elks story: The website should prove to be useful to Members. It should also successfully tell the Elks' story to non-Members.

Local Lodges should enter the website contest for their respective state no later than October 1, 2021. Lodges in states not holding a state contest may send their application to their Area Representative on the Grand Lodge Fraternal Committee (elks.org/grandlodge/fraternal/roster.cfm). Lodges that have no website but feel like their Facebook page exhibits all these qualities may also enter. All pages and websites will be visited three times during the year by the Website Contest Administrator.

This contest is a great way to get your Lodge or State Association recognized nationally. It is always important to recognize those who do such a great job. This is also a way to get help for those who desire to improve their webpage. Please use the aforementioned guidelines to ensure your website and/or Facebook page is the best resource for Members and non-Members alike.

State Contest winners will be announced in the March 2022 issue of the GL Newsletter and the Lodge Contest Winners will be published in the April 2022 edition.

# Little Free Libraries provide easy access to books

Elks always care for children in need, and children's literacy is no exception. Due to COVID, many Lodges have had to refocus their favorite literacy projects and find new and exciting ways to engage children in their communities. Milwaukee, WI Lodge No. 46 reconsidered how to distribute reading materials to make its Gratitude Grant project both safe and accessible.

Inspired by the Little Free Library program, the Milwaukee Lodge set its sights on a little library of its own. Elks volunteers are building little libraries in different areas of the community and stocking them with books for children and families to borrow, read, and swap out. Small, free libraries make reading materials accessible for children, even those whose families may not have access to reliable transportation to the public library or the funds to buy books.

"We hope that this project will improve reading comprehension and literacy rates by making books more available to not only children to read themselves, but for parents to read to infants and preschool aged children," said Elisabeth Mulvany, Leading Knight for the Lodge.

According to a recent study in the United Nations News, the rate of children who are experiencing difficulty reading has increased more than 20% in the past year due to the pandemic and subsequent school closures. And, Little Free Library cites that two out of three children living in poverty have no books to call their own. Providing accessible reading materials for children and families is the first step toward improving literacy rates.

If your Lodge is looking to work on children's literacy in your community, the possibilities are plentiful.

"There are so many ways to encourage literacy—contests, summer reading challenges, book exchanges, storyteller sessions for children, giving books as gifts, volunteering as tutors, or hosting 'reading clinics' for kids," Mulvany said. "Instilling the importance and fun of reading is more

important than ever."

3. Inform the instructor that your Lodge will provide them with a certificate and a medal to present to the cadet they select. Your Lodge may want to have a Lodge Officer(s) or Member(s) attend the ceremony to make the presentation to the cadet, if permissible.

4. If your Lodge holds a banquet/ dinner to recognize outstanding youth in your community, you should consider inviting the cadet and their family.

5. A printable and fillable JROTC certificate is available on the Grand Lodge website under the Activities Committee at: elks.org/grandlodge/activities/files/ JROTCAwardsProgram.pdf. The JROTC Medal can be ordered from the Grand Lodge Supplies/Shipping Department by using CLMS. The item number is 575300 and the cost is \$10.00 each plus shipping and handling. The JROTC medal makes a terrific companion gift to the JROTC certificate. Any cadet will be proud to receive both awards.

Over the past 20 years, Elks leather has been used to make 600,000 craft kits, for a total estimated value of more than \$15 million.

Help Heal Veterans, a nonprofit dedicated to serving SERVICE military veterans by supplying them with free therapeutic craft kits, has chosen the Benevolent and Protective Order of Elks as its 2021 Partner of the Year. As a partner for over 20 years, the Elks have donated more than 923,280 square feet of leather to

## "Phase Two" membership push begins

We began the new fraternal year recovering from a large membership loss. We created a proactive post-pandemic recovery plan to help us regain our membership footing. Our priority was to re-engage and win back lapsed Members. Having a strong renewal rate gives us the best foundation possible for sustainable, healthy membership growth.

In April we came out of the gate strong with a multi-channel reinstatement program. Our "Phase One" reinstatement plan produced nearly 7,000 memberships. Our "Phase Two" multi-channel optimistic about membership.

reinstatement plans begin in September. It will include a 50,000 direct mail campaign to former Members. It will be complemented by a targeted e-mail campaign and social media campaign.

Adding to our optimism is the new billing program's game-changing results. It has produced a single digit delinquency percentage in the first half of the year. We have added more than 30,000 new Elks to the rolls. We have more than 14,000 candidates still in the pipeline. With an excellent Member retention percentage, along with excellent Member acquisition numbers, we are highly encouraged and
