

This contract for the rental of a facility is made this day, ______, by and between B.P.O. Elks Lodge #309, hereafter referred to as Elks Lodge and ______, hereafter referred to as the Client.

Whereas, the Client desires to temporarily rent, occupy, and make use of the Elks Lodge facility, located at 3400 N. Nevada Ave. Colorado Springs, CO. 80907. Whereas the Elks Lodge agrees to such rental, occupation, and use in consideration of certain payments and covenants herein enumerated;

Now, therefore, the parties agree to the following terms and conditions:

- 1. The Client shall pay to the. Elks Lodge the sum of \$350 immediately to confirm the event date and to act as a damage/security deposit.
- This amount is a non-refundable deposit should the client cancel the event within 60 days of the scheduled event. Thereafter, the \$350 is a damage deposit which will be returned to the Client within 14 day after the event, minus any charges for actual damages done to the venue by Client or his/her guests. In the event the damages done to the facility by the Client or his/her guests exceed the damages/security deposit, the Client understands he/she will be responsible for the remaining balance for the damages.
- 2. Client shall remove all personal property and other items that were not present in the Facility when Client took control of it upon the completion of the event.
- 3. Upon Client's completion of his/her obligations under (2) above, the Elks Lodge shall return to Client the security deposit minus any amounts deemed necessary to repair damages inflicted upon the venue by Client and/or Client's associates, guests, invitees, and all other persons whatsoever who enter the facility during the rental period, whether or not such persons did so with Renter's knowledge or consent. The Client will be notified regarding any repairs necessary to restore the facility to its original state and the amount withheld from the deposit or the remaining balance the Client is required to pay to repair/clean damages.
- 4. In the event that Client fails to pay the balance due as shown below within the time period agreed upon in this contract, interest shall accrue upon the unpaid balance at the rate of 12% per year until it is paid. Client shall also be liable to Elks Lodge for any legal fees, court costs, and other expenses associated with collection.
- 5. Client will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that the Elks Lodge may incur as a consequence of the actions of Client or any of the Client's guests while Client is in control of the facility, and shall indemnify and hold harmless the B.P.O. Elks Lodge 309 against any and all legal actions which may arise from Client's use of the facility.

- 6. Any disputes arising under this contract shall be adjudicated in the B.P.O. Elks Lodge 309's local jurisdiction.
- 7. The Client further agrees to pay the Facility Fees for Event Usage as listed below in accordance to the times agreed on between the Elks Lodge and the Client.

Room Rental

Room rental rates are based on the room(s) of your choice and by the number of people in attendance, plus other miscellaneous requests.

Room rental rates are for up to 6 hours in duration; additional hours will be charged by the hour at \$125 per hour. Rental rates include tables, chairs, white linen table clothes, set up and tear down. Extra time will be allowed for decorating and clean-up when possible. Event end times are no later than midnight.
