



History of the Elks

Why are We Elks? Not why did we join or why we pay our dues every year, but why, who, when, and how the Elks came into being and how it has evolved from its roots. What follows is an examination of events that would contribute to the formation and foundation of this great Order.

Chapter 11 – Colorado Stories

In April 1882, the first Lodge between the

Mississippi River and the Pacific Ocean was instituted in Denver, Colorado. A combined degree team from St. Louis Lodge #9 and New York Lodge #1, representing the Grand Lodge, presided over the ceremony and initiated 22 Charter Members.

The Lodge had several locations in and around the downtown area before the permanent quarters opened on the corner of 14th and California in 1912. Ornate leaded stained glass panels were found throughout the original building.

In 1974, the old building was sold, but most of the stained glass was saved and is in the current Lodge on

At the 1914 "Golden Jubilee" Session of the Grand Lodge, Denver 17 was recognized for assisting in the formation of 29 Colorado Lodges and most of the Lodges located Wyoming. As a result,

In 1901 the Leadville Elks purchased the famous Tabor Opera House.

As the story goes, Vivian's final onperformance would be on the very stage that his Brother Elks would hold the weekly meeting

Leadville 236 for over 50 years.

The history of our Order is as colorful as the men and women who have written it. Sadly, as we lose older Members, we lose the un-recorded stories of our Lodge.

It should be our mission to preserve our history. To be

proud of the Fraternal Order we belong to share these stories with new and upcoming Members, so they may add their own chapters to the annals of memory.



Colorado Elks Association

State Associations are organized to promote the purposes and principles of Elkdom in the states and to support its member Lodges by conducting educational programs that assist officers



and members in promoting Elkdom and performing community service programs supported and promoted the Grand Lodge. Basically these are programs reviewed previously, along with service programs devised by local members.

In addition to Grand Lodge Programs there are some that are unique to the 54 Colorado Elks Lodges

Clem Audin Fund

If there is there a child in your jurisdiction that needs clothes, eyeglasses, medications, books, school supplies the Clem Audin Fund will provide grants up to \$200 per child when requested. Each Lodge should have the Procedures for Clem Audin Request Manual and Request for Funds forms.

Colorado Elks Major Project Laradon Hall

Laradon Hall is well-known for their work with men and women of all ages who have a variety of disabilities. Laradon was adopted as the Elks Major Project in 1950. Laradon is one of Elkdom's oldest continuous Major Projects and enjoys local, state and national recognition within the Elks community.

Laradon provides education, group homes, employment opportunities and a place where these people can live and learn. Future plans call for a new school to better educate their clients.

Catch-a-Calf and Heifer Wrangle

Catch-a-Calf is a Colorado State 4H Council program and Heifer Wrangle is a Colorado FFA program. Our rural youth through these programs gain an understanding of the cattle industry; while learning production skills, showmanship, recordkeeping, and public relations through local Lodge sponsor contacts.

Leadership Development Seminars

Colorado Elks put on seminars for officers. The Leading Knight, Secretary, and newest Trustee are encouraged to attend, but the seminars are open to all Elks. These weekend Seminars are held several times each year and include Sunday training for spouses. The seminars are held at a host Lodge somewhere in the Denver north metropolitan area, south around Colorado Springs/Pueblo area and on the Western Slope.


History of the Elks

In the beginning

It was 1963 and the call went out to start an Elks Lodge in Glenwood Springs. It was answered by a group of dedicated men determined to build a strong and enduring Lodge.

They formed a corporation and purchased the old Burge Mortuary building on Highway 6 & 24, along with the land and trailer park behind.

The original bar was constructed from empty coffin delivery crates. They purchased some whiskey and beer and were ready to go, until they discovered that they couldn't sell any alcohol without a liquor license. They called over to the State liquor board and

spoke to Andy Anderson. He told them their license number; they wrote it on a brown paper bag, tacked it to the wall and were in business.

Although the coffin empty crates were sturdy, they weren't very fashionable and it was soon decided they would need a more permanent bar. A restaurant in Basalt was remodeling and group purchased their bar, found a member with a truck and drove to Basalt to pick it


Since that time the Lodge has grown in membership and increased community activities, including support of a local service similar to Laradon Hall, Hoop Shoot, Soccer Shoot, scholarships and a great veterans service program.

Several remodeling projects have turned the building into an open airy social center that hosts evening meals seven days a week and welcomes visitors from all over the country.

Organization of the Lodge

The Exalted Ruler has a rather simple Table of Organization. He is connected with everyone in the organization by a simple line of leadership and authority. He has the sole authority to appoint and remove committee chairs.

He is by virtue of his office a member of the Board of Directors and the House Committee and is an ex-



officio member all the rest of the committees.

He can, if he desires, sit in on all committee meetings and participate in discussions. Unless he has appointed himself to a committee, however, he has no vote, although as Exalted Ruler he has some influence on the committee actions.

He is Chairman of the House Committee, unless the By-Laws provide a separately appointed House Committee, other than the Chair Officers and Trustees. And he is also available to all the members.

The Knights of the Lodge are the Vice Presidents and each is assigned coordination duties with Lodge committees.

Lodges also have the usual Secretary and Treasurer, as well as a Board of Directors to look after the property and funds of the Lodge.

Specific to Glenwood Springs

Glenwood Springs Lodge #2286 sponsors Boy Scout Troop #225 and works with Cub Scout Troop #225, and some of our members are actively involved with Girl Scouting. We provide financial support to these troops as well.

We have an active Veterans Support Committee that conducts several veterans programs, including periodic mailings of comfort boxes of supplies to soldiers stationed in war zones and other areas around the world.

The Lodge also supports Operation Vacation, Wounded Warriors, Hides for Veterans, the Rifle Veterans nursing home, collection and distribution of books for veterans, collection of cell phones, and other programs.

The Lodge provides scholarships from our general fund as well as from a Perpetual Scholarship Trust Fund that spends only income from investments for education grants.

Among regular fund-raisers for the Perpetual Fund are the hamburger stand at Strawberry Days, winter darts tournaments and other spur-of-the-moment special projects.

Another major project is the Memorial Dinner held each December and at the same time we distribute food baskets to the needy.

Other activities include golf tournaments, cribbage at the Lodge, darts tournaments, shuffleboard tourna-



ments, a yard sale, giving dictionaries to every third grade student in our local schools, weekly bingo, football parties, periodic holiday parties, contests, etc.

Some of these are social events, others are strictly community service, but in most cases they all are a little of both at the same time.

Most of our activities are generated by suggestions of members who see a need and convince others to help them solve a problem or do a good deed. The best community service comes from the needs and desires of our members.

Why Hoop Shoot?

The grit movement started a few years ago when psychologist Angela Duckworth studied people in challenging situations, including National Spelling Bee participants, rookie teachers in tough neighborhoods, and West Point cadets. Her research suggested that grit was a more accurate predictor of success than social intelligence, good looks, physical health, or IQ.

Through the Hoop Shoot program, the Elks has been developing and reinforcing grit for more than 46 years—long before researchers and experts concluded that grit is so important for our children.
