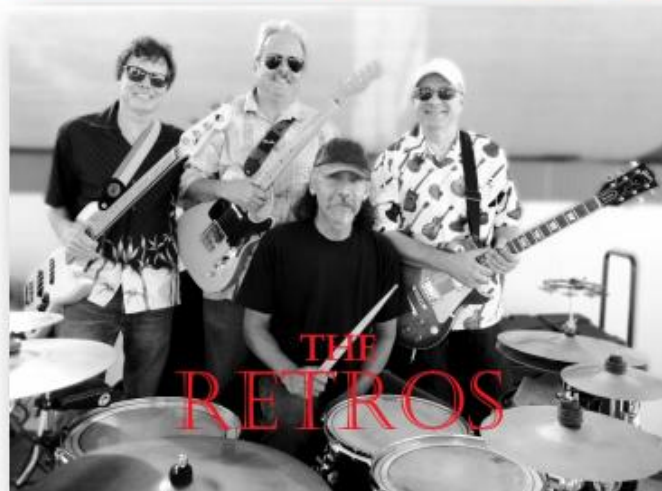

**A Message from Leading Knight,
ELIZABETH DYE, PER**

Fellow Elks,

Last month approximately 11 Elks from the Redondo Beach Lodge attended the Grand

Lodge Convention in Tampa, Florida. If one wants to thoroughly understand what the Elks organization is truly about and understand the enormous impact, we Elks have had on millions of people and communities, I suggest attending a Grand Lodge Convention. I took advantage of the many workshops, training and information sessions that were offered. Among them were Membership & Marketing, Drug Awareness, Activities, All-American Lodge Contest, Financial and Business, ENF, Hoop Shoot and Scholarships. Each provided exciting insight not only on how these programs work, but how many people our programs touch and the changes that we make in the lives of those we've never met. One of the programs that most impressed me was the **"Elks Veterans Leather Program."** This program was started in 1948 and relies on the charity of hunters across the nation to donate hides. Elks collect, prepare, and process the hides. The leather is then crafted into occupational and recreational therapy kits that are provided to veterans nationwide to help them learn new skills and recover from devastating experiences. Leather kits are used in the **Help Heal Vets Program** by therapists who work with vets suffering from brain injuries, PTSD, and substance abuse. Many veterans are prisoners in their own minds and working with these kits help with their motor skills and take their minds off their suffering and chronic pain they experience 24/7. The Leather is also used to provide professionally crafted gloves for veterans who use wheelchairs. I never thought about how or why one pair of gloves could be like gold to a wheelchaired veteran. In 2018-2019, Elks in **18** states donated a total of **19,808** hides to this program. **3,460** veterans received free wheelchair gloves from the Elks. Elks donated **68,429** square feet of leather, worth **\$307,927** to the non-profit Help Heal Veterans to make craft kits for recovering veterans, and Elks distributed **8,378** craft kits to veterans in our communities. My fellow Elks, **THIS** is what we call being charitable. This year, I would like to see **us** participate in some way with this most honorable and charitable veterans program.

The stronger your Lodge, the greater benefit to your community. With the various grants from the Elks National Foundation, we can readily add to existing Community Service Projects. Others are competitive. However, ENF personnel are there to assist you with these proposals.

The Elks Most Valuable Student applications are now open and online. Create a little explanation sheet or download one from elks.org. Then call your high school counselors to inform them of our program and where they can direct their seniors for the eligibility requirements and application. Follow up that call with a small letter. Remember we also have the Student/Teenager Month and Year Program. This is one way for your Lodge to recognize high school students for their work and volunteerism. Look into this program within the Grand Lodge Youth Activities Program Manual. Finally, this week, visit Elks.org. Under the Fraternal Committee, print off the "Patriotism Week Proclamation." Have your city mayor sign it to proclaim September 6 -12, 2021 as National Patriotism Week in your town. Then, use this opportunity to encourage new Members to join our great Order.

REDONDO BEACH ELKS HOUSE RULES

Several members have asked us questions regarding our Lodge's house rules with the operation of our member's bar. Here is an excerpt from our By-Laws, Rules of Order and House Rules. **For a full copy of Redondo Beach Lodge 1378 By-Laws, Rules of Order and House Rules, go to [Elks.org/Redondo Beach](https://Elks.org/Redondo%20Beach).** Also, the Members Duties and Member Privileges are posted at the South Bar entrance.

**Excerpt from By-Laws, Rules of Order and
House Rules (Amended 11/20/2020)**

Member Duties

1. It is the duty of the Members to comply with the House Rules and to assist in upholding and maintaining the dignity of an Elks Club.
2. It is the duty of the Members to report all violations in a signed letter to a member of the House Committee.

House Rules (continued)

3. All suggestions regarding the Elks Club should be directed in a signed letter to the House Committee.
4. The use of profanity or obscene language, ungentlemanly or unladylike conduct or harassment in or about the Lodge facilities will subject the Member to disciplinary action. You must be sensitive to the feelings of others and must not act in a way that might be considered harassment by someone else. If you think that you or someone else has been mistreated or are victim of harassment on the Lodge property you must report the incident and the name of the person(s) to a member of the House Committee or an Officer immediately. The incident will be investigated. If you do not report harassment, it cannot be investigated. Your cooperation is crucial. There will be no retaliation against you by anyone for making a complaint of any form of harassment.

Member Privileges

1. Members and/or their spouses may be required to show their current Membership/Identification Card at any time.
2. Only Members in good standing in this or any other Lodge of the Order may enjoy and have privileges of the Elks Club within these rules.
3. Members may bring a maximum of six (6) guests per visit into the Social Quarters of the Lodge for whom they will assume full responsibility for their conduct. These guests may only remain as long as the Member remains. If the Member has more than six (6) guests, they will be required to apply for a facility rental. Guests visiting the Lodge (not part of a private rental party), excluding immediate family members and/or visiting Elks, are permitted three visits with a Member; and thereafter will be required to submit an application for membership in the Lodge.
4. Members shall sign in their guests in the Visitor's Register.
5. Guests will not be permitted when the Lodge is in regular session or special session unless they are invited by the Lodge.
6. There shall be no possession or consumption of alcoholic beverages on the premises by Members and/or guests during regular or special sessions of the Lodge.
7. It is the position of the Lodge that all beer, wine and liquor purchases will only happen

within the Lodge bars. No individual Lodge event may purchase alcohol for its patrons.

8. All rules regulating gaming tables and card games shall be under the supervision of the House Committee.

9. The House Committee shall have the power to prohibit any and all games or practices, which, in their opinion, may be likely to bring the Lodge or Club into disrepute or interrupt its harmony.

10. On meeting nights all services of alcohol and all playing of games must cease in the Social Quarters (10) minutes before the start of the regular and/or special Lodge meetings and may commence after the Lodge session.

11. If a Member or group of Members wishes to sponsor an event that sells food to the Members and/or their guests they must obtain approval from the House Committee prior to the event. All funds received are to be submitted to the Secretary of the Lodge, according to Grand Lodge Statutes. An Event Form is to be completed and submitted to the House Committee after the event is completed.

12. Rental of Lodge Facilities for Member rates is restricted to Members with one or more years of membership. Member sponsored events are limited to two per year.
