
MESSAGE FROM Mike Huffman, Jr. Exalted Ruler

1 package (6oz) stuffing mix for chicken

- 4 boneless skinless chicken breast or thigh pieces
- 1 can (10 1/2 oz) cream of mushroom soup
- 1/3 cup sour cream
- 1 cup warm water
