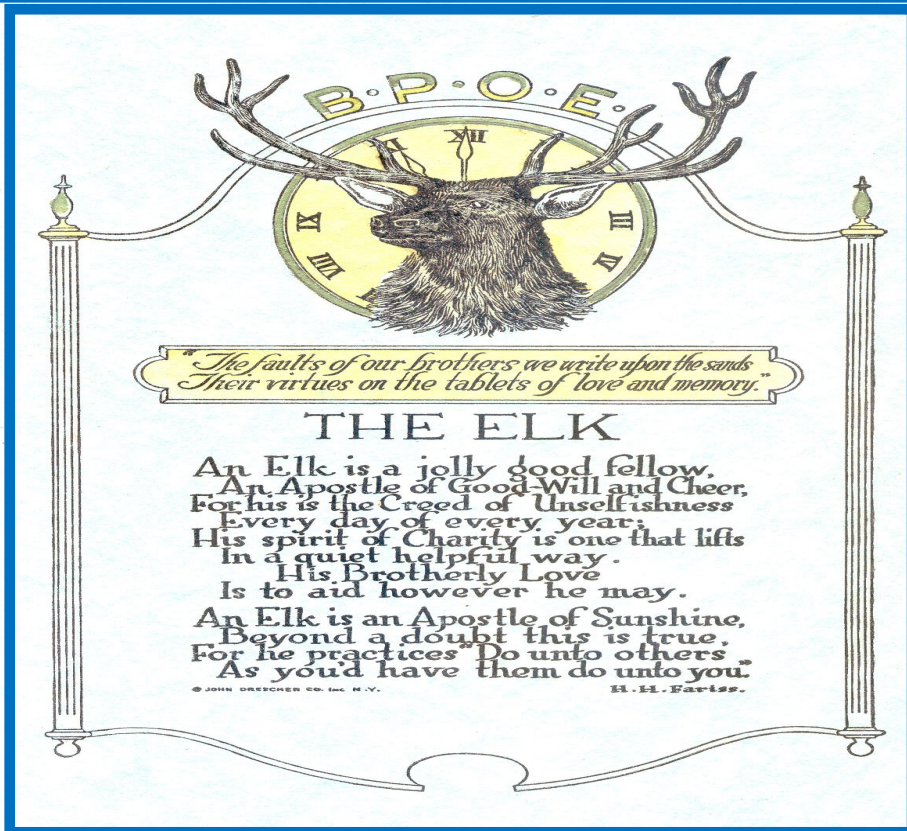

Did you know that Flag Day, a National Holiday was created by the Elks?  
Flag Day, this year, is on Tuesday June 14th, but we will be observing it with a Special Ceremony on Saturday, June 11th at 3:30 pm.

In 1907, the Benevolent and Protective Order of the Elks, designated June 14th as Flag Day. Then in 1911, the Grand Lodge adopted a mandatory observance of Flag Day, and that requirement continues today. The Elks then prompted President Woodrow Wilson, who was in office from 1913 to 1921, to recognize the Order's observance of Flag Day, for its patriotic expression. It was not until 1949, when President Harry Truman, an Elk himself, made the proclamation that June 14th, become a day of National observance, for the symbol of our country.

Please come and join us on Saturday, June 11 at 3:30 pm to honor our Country's Flag. The Father's Day Celebration is to immediately follow.

## BAKERS CORNER

### Chocolate Sheet Cake by Pat Giacomo

1 ¼ Cups Margarine or Butter (divided)  
½ Cup Unsweetened Cocoa (divided)  
1 Cup Water  
2 Cups Unsifted Flour  
1 ½ Cups Firmly Packed Brown Sugar  
1 tsp Baking Soda  
1 tsp Cinnamon  
½ tsp Salt  
1 (14oz) Can Eagle Brand Sweetened Condensed Milk (divided)  
(NOT Evaporated Milk)  
2 Eggs  
1 tsp Vanilla Extract  
1 Cup Confectioners' Sugar  
1 Cup Nuts



Preheat oven to 350°. In small saucepan, melt 1 cup margarine; stir in ¼ cup cocoa then water. Bring to a boil; remove from heat. In large mixer bowl, combine flour, brown sugar, baking soda, cinnamon and salt. Add cocoa mixture; beat well. Stir in ½ cup Eagle Brand, eggs and vanilla. Pour into greased 15 x 10-inch jellyroll pan. Bake 15 minutes or until cake springs back when lightly touched. In small saucepan, melt remaining ¼ cup margarine; stir in remaining ¼ cup cocoa and Eagle Brand. Stir in confectioners' sugar and nuts. Spread on warm cake.
