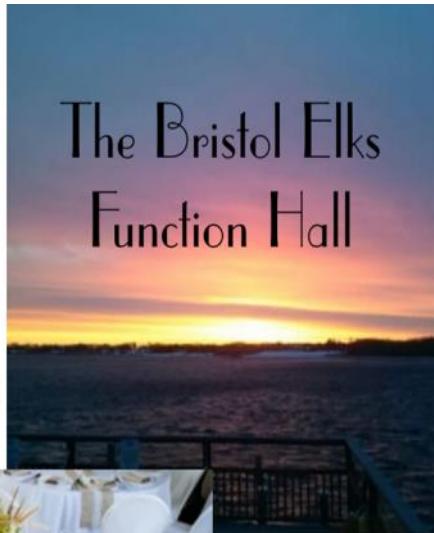

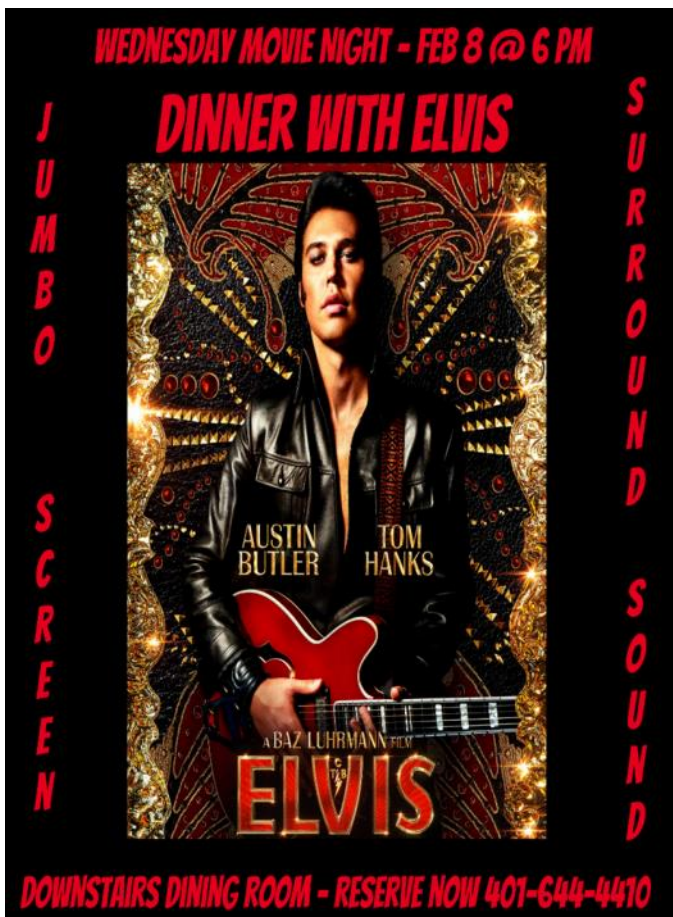

*Popular themes in this year’s submissions included fairness, inequality and fighting racism, says Bart Ferris, one of the volunteer judges. “There was a lot of wanting to help the world.”*
