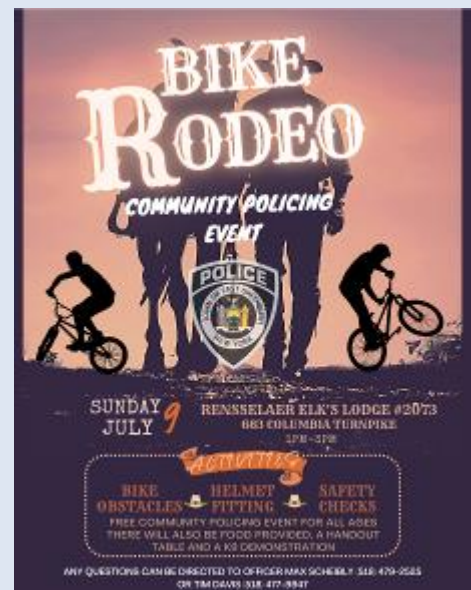

A Reminder of Lodge House Rules

1. This Lodge under the provisions of the Dispensation and Charter, shall be known as Rensselaer, New York Lodge No 2073 of the Benevolent and Protective Order of Elks of the United States of America, Inc.
2. The building and premises occupied by this Lodge shall be known as Rensselaer Elks Home and shall be for the exclusive use of its Members in good standing.
3. The operation, management and control of the Home occupied by this Lodge shall be supervised and conducted by a House Committee of thirteen Members to be appointed by the Exalted Ruler.
4. The House Committee shall have the responsibility of the management of the Club, to engage or dismiss any person employed by the Club, and to regulate prices of articles sold in the Club.
5. The House Chairman and Committee shall have the right to set hours of the Club operation and determine what days to close the Lodge.
6. Members in good standing shall be permitted to bring guests into the Home who are eligible for membership except on meeting nights and special occasions called by the Exalted Ruler.
7. No one under 21 years old will be permitted at the bar.
8. Personal checks cashed at the bar will be limited to a minimum of \$5.00 and a maximum of \$100.00. No monies of the Lodge shall be loaned to any Member for any reason.
9. All visiting Elks, upon entering the Lodge, are requested to register in a book provided for that purpose and the Member introducing such visitors shall at the same time add their name to such register and remain with their guest until such guest departs. Members introducing visitors must be responsible for their conduct when in the building. All visitors, not an Elk, must be accompanied by a Member; and any property broken or damaged by the guest of a Member shall be paid for by the guest immediately upon receipt of a bill for the value of such damage.
10. No gambling or gaming devices of any kind shall be permitted in the building unless such gambling is licensed by the laws of the State, and also by the local municipalities, and such license will be made available and displayed on demand.
11. No games shall be played in the building nor shall anything be served during Lodge sessions. Lights shall be extinguished during the 11 o'clock toast with the exception of those necessary for the proper conduct of such occasions.
12. No Member shall take from the building any article(s) belonging to the Lodge without written itemization and approval signed by a member of the Board of Trustees. Kitchen items may not be removed without written itemization and permission of the House Committee Chairman.

A Reminder of Lodge House Rules

13. No refreshments shall be removed from the kitchen or any part of the Lodge, without permission of the House Committee Chairman or unless served by a member of the Committee at a social function of the Lodge.
 14. No dogs, cats or pets shall be permitted in the building, except for certified service animals.
 15. The Bartender shall refuse to furnish a Member or guest with refreshment when he or she deems it wise not to do so.
 16. Vile, indecent or offensive language or conduct will under NO circumstances be permitted in the Home.
 17. The House Committee in charge of the Home shall enforce these Rules at all times. Anyone alleged to be guilty of acts unbecoming an Elk or violating these Rules shall be reported to the House Committee for further action.
- Any dispute among Members should first be addressed to mediation by an impartial party.
18. The House Committee requests that Friday night of each week be regarded as Family Night when a general attendance of Members and their families may be expected. All Members must supervise their children's conduct and shall be held responsible for their close supervision, manners and decorum. No children will be allowed in the Lodge without their parent or guardian and shall not be allowed to run about the building or disturb other individuals. Any responsible person may notify the parent or guardian to control their children's behavior.
 19. No person under the legal drinking age of 21 years will be allowed at the bar, nor shall such individuals be allowed to consume alcohol inside the Lodge or anywhere on the premises.
 20. Instructions to any employee of the Lodge shall pertain to Lodge business only and shall be given by the House Committee Chairman, the Exalted Ruler or a House Committee member.
 21. Saturday night Lodge functions, socials, dinner parties and ladies nights required that all Members and guests shall be attired in socially acceptable and appropriate attire for such functions.
 22. Only authorized persons are allowed behind the bar, such as the Bartender on duty, or anyone with permission of the Bartender if he or she needs assistance or deems it necessary. Any other individuals require the permission of the House Chairman, the Exalted Ruler or a member of the House Committee.
 23. The over service and consumption of alcohol as defined by local law and ordinance is strictly prohibited; this rule shall be applicable to all Members, Officers, and employees of the Lodge pursuant to Grand Lodge Statute 17.052.

Donate Old or New Sneakers

Our first 2 bags of sneakers have been collected!

The sneaker donation box is in the lounge. We are collecting all kinds of sneakers – new, old, tennis, basketball, soccer sneakers with rubber cleats, baseball sneakers with rubber cleats. Wearable sneakers are worth more than unwearable, but, we also collect unwearable sneakers. The only exception is the sneakers must be a matching pair. All proceeds will be donated to the lodge. This program is supported by Got Sneakers. Wearable sneakers are donated to people in need. Unwearable sneakers are recycled to programs that can use the materials used in sneakers.
