Proposed revision to Viera Lodge By-Laws

ARTICLE V: ELECTIVE OFFICERS AND DUTIES

OF THE SECRETARY

Section 4. Currently reads in part: "For the faithful performance of his duties shall receive as compensation \$4,800 per annum, payable every two weeks."

Proposed amendment to read: "For the faithful performance of his/her duties shall receive as compensation \$6,000 per annum, payable monthly."

OF THE TREASURER

Section 5. Currently reads in part: "For the faithful performance of his duties shall receive as compensation \$2,400 per annum, payable every two weeks."

Proposed amendment to read: "For the faithful performance of his/her duties shall receive as compensation \$6,000 per annum, payable monthly."


