



Message from the Exalted Ruler, Cindie Pridy

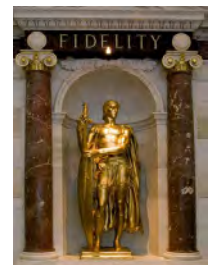

Message from the Board of Directors

Here we are in our first month of the Lodge year and the trustees continue to work assiduously in support of our Lodge. In addition to closely analyzing the Lodge investments and presenting a brief overview to members at the first or second meeting of the month we have a few projects we believe are noteworthy for this year. Here are some the highlights:

Budget:

The Board Budget Committee has completed preliminary budgets for the Lodge, Dining, Club, Bingo, Charity and PER Association. At this writing the entire Board of Directors will meet, discuss review and approve these budgets in preparation to submit to the Members for approval and adoption. I hope to have them all approved by the second meeting this month. All the budgets are balanced and most have a favorable income. With the constant monitoring by the Board and House Committee we expect to be in a much better position than the previous Lodge year.

Facilities and Infrastructure:

Efforts are underway to contract with a pool company which will resurface our swimming pool and commercial type cleaning services for specific areas of the Lodge. In addition, we are reviewing contact for our grounds keeping, RV hookup repair and other maintenance projects. In addition, I have asked all Board Members to review our current capital plan for possible new projects for the Lodge such as replacement of the carpeting and kitchen upgrades.

The Board of Directors continues to work diligently protecting and managing the assets of the Lodge and the Members of Houston #151. We welcome any member to attend our regularly scheduled monthly Board meeting and provide constructive comments and recommendations for future success.

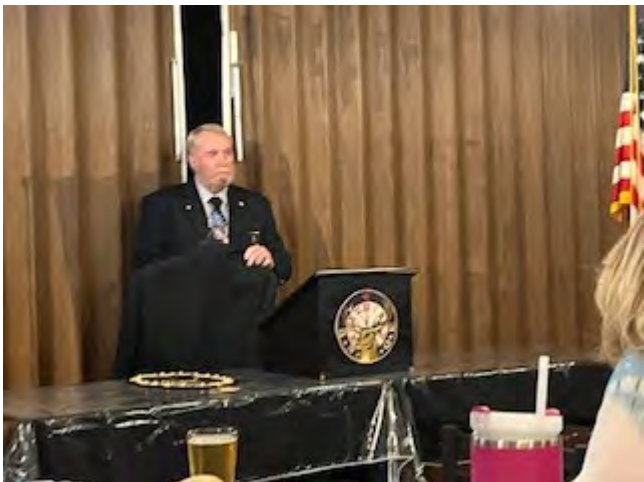

As Elks, I believe that we are held to a higher standard than non-elks. Just like Police Officers, Judges as well as those who are elected or appointed in our order are to be held to a higher standard. You give up the safety of anonymity when you place yourself above the common member. Lincoln once said, "When you place yourself above the common crowd you become a target." True words from a very tall man who placed himself way above the common man,

When an Elk undergoes the initiation process, they swear solemn oaths and place themselves under obligation to carry out certain acts and behaviors. Nothing they will say or do will ever violate their consciences; however, their behavior must reflect Brotherly Love, Charity, Justice, and Fidelity always with all people. If they violate their oath they can be banished from the order and never again be associated or in the company of Elks in good standing. This clothes us with a heavy mantle of responsibility.

Soon many of us in the Lodge will be accepting additional responsibilities both to the order and our Lodge's membership. Members will be installed into leadership positions from Exalted Ruler to Inner Guard, both elected and appointed. They will be given instructions and swear an oath to be faithful to the positions that they will hold with solemn obligations.

Others will be assigned positions to chair committees or be members of them. Again, each position within the Lodge and organization carries a mantle of responsibility with it. Each position must be carried out diligently and with a good conscience keeping the membership always in mind as it is to them that you are obligated to as well as their own good conscience.

Are these easy tasks? No. There will be times when you must act correctly even if it means being seen differently in the eyes of a member or members. It is at these times that you must be strong and a person of conviction adhering to your oath, obligation, and conscience. As Lincoln said, that is when you may become a target.
