# **Important Dates**

- Applications open April 1
- Applications close January 22, 2025
- Projects need to be completed, and all funds must be spent, by March 31, 2025



#### **General CIP Guidelines**

#### Grants should follow IRS-defined charitable categories:

- Relieve the poor, distressed or underprivileged
- Advance education and science, but not through scholarships
- Lessen the burdens of government
- Combat juvenile delinquency and community deterioration
- Lessen neighborhood tensions



#### Grants <u>may not</u> be used for:

- Fundraisers or memorials
- General community events
- Poster or essay contests
- Appreciation meals or events
- Youth awards nights or scholarships
- The benefit of Lodge members or families
- Hoop Shoots, State Major Projects, or National Elks Programs
- Salaries for Lodge employees or volunteers
- Projects that have already happened
- Donations to individuals



# **Spotlight Grant Basics**

- \$2,000 grant is available to every Lodge
- Used for one of seven ready-made projects
- Projects focus on three issues facing every American community
  - Family literacy
  - Veteran homelessness
  - Food insecurity
- Cannot be split between multiple projects





# Warm Welcome to the Library

- Partner with the local library
- Provide coats to children and introduce families to all that their neighborhood library branch has to offer
- Can be done in partnership with Operation Warm, but not required





#### **Suds & Stories**

- Make the local laundromat a center for childhood literacy and development
- While guests do their laundry, entertain their children with literacy activities





# Community Baby Shower

- Consult with local hospitals, women's shelters, and other organizations
- Purchase supplies such as
  - diapers
  - baby formula
  - blankets
  - children's books
- This project requires a literary aspect





### **Welcome Home**

- Help make a house a home to veterans transitioning from homelessness
- Contact groups such as the VA, which can identify when and where veterans are transitioning into permanent housing
- Supply basic home goods such as furniture, appliances and cutlery, or home items that are requested





#### **Stand Down**

- Coordinated by local V.A.
  Medical Centers and other service
  providers that offer various
  services and resources
- Purchase supplies like clothing, tents or hygiene supplies, or cook a meal for the veterans that attend





# Adopt-a-Haven

- Partner with an emergency shelter or a transitional housing facility specifically for veterans
- Offer positive social and material support through maintenance projects, monthly dinners or other social events





# Hunger and Essential Needs Assistance

- Provide essential needs assistance by providing food, hygiene products, and other items not covered by SNAP
- Lots of project ideas
  - Provide baskets of essentials
  - Deliver meals to seniors
  - Start community garden
  - Build Little Free Pantry
- Do not wait until the holidays to provide support







#### **What Are Essential Needs?**

- Items crucial for maintaining basic hygiene, health, and well-being
  - Food
  - Hygiene Products
    - Soap, Shampoo, Deodorant
  - Household Cleaning Supplies
  - Diapers and Formula
  - Tents and Sleeping Bags
  - Winter Clothing
- Not pins, flags, Elks-logo shirts or hats, sports equipment, luxury goods, electronics, or entertainment products



# Merging a Spotlight Grant

 Beacon Grants can be merged with a Spotlight Grant to make a \$6,000 Beacon Grant

Merge Spotlight + Beacon

- Spotlight Grants can also be combined with the Lodge's Gratitude Grant
  - ☑ Yes! Please combine my lodge's Spotlight Grant with a Gratitude Grant



# **Final Reporting**

- Be sure to keep your receipts!
- For donation receipts, we need either:
  - A copy of the cashed check, which can be acquired through your bank.
  - A thank you letter from the organization that received the donation (typed on official letterhead, with the amount donated specified).







# **Staying in Compliance**

- Overdue Final Reports
  - Due 30 days after project completion
  - Out of compliance after 60 days
- Malfeasance
- Delinquent Dues
- Compliance status can be found in the <u>CIP Participation Report</u>
