## **Important Dates**

- Applications open April 1, 2025.
- Bonuses are finalized by the end of April.
- Applications close January 21, 2026.
- Projects need to be completed, and all funds must be spent, by March 31, 2026.



### **General CIP Guidelines**

### Grants should follow IRS-defined charitable categories:

- Relieve the poor, distressed or underprivileged
- Advance education and science, but not through scholarships
- Lessen the burdens of government
- Combat juvenile delinquency and community deterioration
- Lessen neighborhood tensions



- Fundraisers or memorials
- General community events
- Poster or essay contests
- Appreciation meals or events
- Youth awards nights or scholarships
- The benefit of Lodge members or families
- Hoop Shoots, State Major Projects, or National Elks Programs
- Salaries for Lodge employees or volunteers
- Projects that have already happened
- Donations to individuals







### **Gratitude Grant Basics**

- \$3,000 base grant
- Four \$500 bonuses available
- Funds local and charitable activities
  - Donations of funds or supplies to 501(c)(3) organizations are allowed.
  - Can be split between multiple projects





**Gratitude Grant Bonuses** 

- Four \$500 bonuses available to eligible Lodges
  - Membership Support Bonus
  - Fidelity Club Bonus
  - Chair Challenge Bonus
  - Fundraising Increase Bonus
- Bonuses are automatically added to applications







### **Membership Support Bonus**

- Lodges in which 15 percent of members donated \$10 or more to the ENF in the prior fiscal year are eligible for a \$500 bonus.
- Lodge status can be checked at the <u>ENF Member Support</u> <u>Report</u>.



# Fidelity Club Bonus

- Lodges in which 5 percent of the prior fiscal year's donors are signed up for the Fidelity Club are eligible for a \$500 bonus.
- Lodge status can be checked at the <u>Fidelity Club Goal Progress</u> <u>Report.</u>







## **Chair Challenge Bonus**

- Lodges that scored 550 points or higher in the prior fiscal year's Chair Challenge are eligible for a \$500 bonus.
- Current Lodge score can be found on the <u>Chair Challenge</u> <u>Score Report</u>.



Fundraising Increase Bonus

- Lodges that increased donations by 10 percent or higher over the previous year are eligible for a \$500 bonus.
- Lodge standing can be found on the <u>Current Year and Prior</u> <u>Year Fundraising Report</u>.

### **Gratitude Grant Bonus Conditions**

☑ Per-Member Giving: \$26.90

Congratulations! Your lodge has met the GER's current per-member giving goal for this year (\$5.00/member), which means you're eligible to apply for a Gratitude Grant next year. Your Lodge can also earn up to four \$500 Gratitude Grant bonuses by meeting the criteria described below.

#### ☑ Membership Support (Goal: 15%)

Congratulations! 109 members of your lodge have donated this year, which is 64.1% of your membership. Since your donor support exceeds 15% of your 170 members, you have met this criteria.

#### ☑ Fidelity Club (Goal: 3 members)

#### ☑ Fundraising Increase (Goal: 10%)

## Supersize it with a Gratitude Grant

- Gratitude Grants can be used to supersize a Beacon or Spotlight Grant.
  - Note: the supersized grant will maintain the original guidelines of the Beacon or Spotlight Grant.
- Supersize in the Budget section of the Beacon or Spotlight Grant application

✓ Yes! Please combine my lodge's Beacon Grant with a Gratitude Grant to increase our maximum grant request to \$6,000.00.



## **Final Reporting**

- Be sure to keep your receipts!
- For donation receipts, we need either:
  - A copy of the cashed check, which can be acquired through your bank.
  - A thank you letter from the organization that received the donation (typed on official letterhead, with the amount donated specified).

# Tahoe/Douglas, Nev., Lodge No. 2670


- Provided a mix of dictionaries and age-appropriate books

- Overdue Final Reports
  - Due 30 days after project completion
  - Out of compliance after 60 days
- Malfeasance
- Delinquent Dues
- Compliance status can be found at the <u>CIP Participation Report</u>.
